BOARD OF COMMISSIONERS LAKE COUNTY FOREST PRESERVE DISTRICT – REGULAR JUNE MEETING MINUTES JUNE 12, 2024

The Board of Commissioners of the Lake County Forest Preserve District met on Wednesday, June 12, 2024 at the District General Offices, 1899 West Winchester Road, Libertyville, Illinois.

10.1 Resolution for Bond Referendum Question for November 5, 2024 General Election Ballot Motion by Commissioner Frank, second by Commissioner Clark to approve a Resolution Providing for and Requesting the Submission of the Proposition of Issuing General Obligation Bonds to the Voters of the Lake County Forest Preserve District, Lake County, Illinois, in an amount not to exceed \$155,000,000 at the General Election to be held on November 5, 2024. Executive Director Kovach gave a summary and a general discussion ensued. Commissioner Maine commented that the Resolution documentation should include the amounts allocated to land acquisition, and to capital projects and restoration; and suggested a motion to amend. Corporate Counsel Norton advised against amending the Resolution, as it was prepared by Bond Counsel. Director Kovach noted that \$65 million would be for land acquisition and \$89,748,000 would be for capital projects and restoration. The 2024 referendum public access improvement projects and habitat restoration projects list that was presented and reviewed at the July 2023 Committee of the Whole was displayed on the screen while Mr. Kovach reviewed the list. During discussion, Commissioner Danforth left the meeting at 9:39 a.m.

Following discussion, with a roll call vote being had, the motion to approve the Resolution passed by a vote of: AYES: 15, NAYS: 0. EXHIBIT NO. 6094
