SUBJECT: Installation of Native Trees and Shrubs at Fort Sheridan Forest Preserve

RECOMMENDATION: Recommend approval of a Resolution awarding a Contract for the Installation of Native Trees and Shrubs at Fort Sheridan Forest Preserve to The Brickman Group Ltd., LLC, of Libertyville, Illinois, in the Contract Price of \$100,906.00.

BACKGROUND: In 2014, The District applied for and was awarded grant monies from the U.S. Forest Service's State and Private Forestry Program for the purpose of performing landscape scale restoration work at Fort Sheridan Forest Preserve. This project will provide the labor to install, mulch, and supply follow-up watering treatments to more than 2,600 native trees and shrubs in order to restore and enhance wooded habitats at Fort Sheridan Forest Preserve.

The project was advertised on March 12, 2015 and four (4) bids were received. A summary of the bids received is listed below:

Staff recommends that The Brickman Group Ltd., LLC, of Libertyville, Illinois be awarded the contract as the lowest responsible bidder. Work is anticipated to begin in September, 2015 and be completed by November, 2015.

REASON FOR RECOMMENDATION: Committee recommendation and Board approval are required in accordance with District policy.

FINANCIAL DATA: This project was approved as part of the adopted FY 2014/2015 Capital Improvement Plan for Preserve Tree Planting in the amount of \$350,000.00. This portion of the project was estimated at \$120,000.00. The actual total of \$100,906.00 will be charged to account 29614100-803200-60010.

















WHEREAS, the Lake County Forest Preserve District (the "District") has advertised in The News Sun for sealed bids for the Installation of Trees and Shrubs at Fort Sheridan Forest Preserve (the "Work"); and

WHEREAS, all sealed bids were received and opened by the District at its General Offices, 1899 West Winchester Road, Libertyville, Illinois on April 1, 2015 at 10:00 a.m.; and

WHEREAS, bids were received in the following amounts from the following bidders, which include bid alternate four:

WHEREAS, the District's staff, the Purchasing Manager, the Director of Natural Resources, the Planning and Restoration Committee, and the Finance and Administrative Committee have reviewed the bids and recommend that the Board of Commissioners find The Brickman Group Ltd., LLC, to be the lowest responsible bidder, and award a contract for the Work to The Brickman Group Ltd., LLC (the "Contract");

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Lake County Forest Preserve District, Lake County, Illinois, **THAT**:

Section 1: Recitals. The recitals set forth above are incorporated as part of this Resolution by this reference.

Section 2: Award of Contract. The bid submitted by The Brickman Group Ltd., LLC, in the amount of \$100,906.00 (the "Contract Price") is hereby accepted and a Contract for the Work is hereby awarded to The Brickman Group Ltd., LLC.

Section 3: Execution of Contract. The Executive Director of the District is hereby authorized and directed to execute the Contract for the Work in the amount of the Contract Price.

Section 4: Payments. The District Treasurer shall make payments under the Contract only pursuant to and in accordance with the Contract terms.

Section 5: Effective Date. This Resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.
