SUBJECT: Contract for the Purchase of Two 2016 Chevrolet Police Impala Sedans

RECOMMENDATION: Recommend approval of a Resolution awarding a contract for the purchase of two 2016 Chevrolet Impala Sedans from Miles Chevrolet, Decatur, Illinois, in an amount not to exceed \$45,281.00 (\$22,640.50 each).

BACKGROUND: In accordance with the District's Vehicle Replacement Schedule, District staff determined that two vehicles for use by Public Safety Department staff were due for replacement.

The two 2016 Chevrolet Police Impala Sedans will replace two 2011 Chevrolet Impala Police Sedans (Unit #099 and #108) and will be purchased under State of Illinois Joint Purchasing Program Contract #4018017 as attached.

REASON FOR RECOMMENDATION: Committee and Board approvals are required in accordance with District Policy.

REVIEW BY OTHERS: Chief Operations Officer, Director of Finance and Purchasing Manager; Corporate Counsel.

FINANCIAL DATA: These vehicles and each of their associated equipment were approved for replacement as part of the adopted FY 2015-2016 Vehicle Replacement Fund Budget (90104100-804100). The total budgeted amount for the vehicles and equipment was \$64,000.00. Actual cost of the vehicles will be \$45,281.00. In addition, an estimated \$9,000.00 in budgeted funds will be spent to outfit the vehicles with equipment such as police lights and sirens.

WHEREAS, the Lake County Forest Preserve District (the "District") desires to purchase two police sedans (the "Vehicles"); and

WHEREAS, pursuant to the Illinois Governmental Joint Purchasing Act, 30 ILCS 525/1, et seq., any governmental unit may purchase personal property, supplies, and services jointly with one or more other governmental units if one of the governmental units has publicly advertised for, and received, competitive, sealed bids or proposals and has awarded a contract for such personal property, supplies, and services to the lowest responsible bidder or highest ranking proposer, all in accordance with such Act; and

WHEREAS, the State of Illinois Department of Central Management Services has, through the Illinois Joint Purchasing Program, publicly advertised for, and received, competitive sealed bids for the Vehicles including a bid by Miles Chevrolet, Inc., in the amount of \$45,281.00; and

WHEREAS, the State of Illinois Department of Central Management Services has awarded a contract for the Equipment to Miles Chevrolet, as the lowest responsible bidder for the Vehicles; and

WHEREAS, it is in the District's best interest to award a contract for the Vehicles to Miles Chevrolet (the "Contract");

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Lake County Forest Preserve District, Lake County, Illinois, THAT:

Section 1: Recitals. The recitals set forth above are incorporated as part of this Resolution by this reference.

Section 2: Award of Contract. The bid for the purchase of the Vehicles submitted by Miles Chevrolet, Inc., in the amount not to exceed \$45,281.00 (the "Contract Price") is hereby accepted and the Contract for the Vehicles is hereby awarded to Miles Chevrolet, Inc.

Section 3: Execution of Contract. The Executive Director of the District is hereby authorized and directed to execute the Contract for the Vehicles in the amount of the Contract Price.

Section 4: Payments. The District Treasurer shall make payments under the Contract only pursuant to and in accordance with the Contract Terms.

Section 5: Effective Date. This Resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.
