



Public Safety Monthly Report

November 14, 2015 – December 14, 2015

Accidents

- Officers located a semi-trailer that damaged the gate at Independence Grove Dog Exercise Area when the driver pulled in and could not complete the turn. Driver cited.

Alarms

- Officers responded to four activated burglar alarms at Countryside and Ryerson. Buildings checked and the alarms secured.

Animal Complaints

- Officers investigated a dog versus dog bite case at Prairie Wolf DEA. Report completed and animal control notified. No major injuries to either dog.

Arrests

- Officers located four juveniles at Greenbelt Lot A smoking cannabis and in the preserve after hours. Juveniles cited and turned over to their parents.
- Officers located a truck that had been driving off road and became stuck at Rollins Savanna. Vehicle towed out and the owner cited. Officers will seek restitution in court for any damage committed by the driver's actions.

Assist Other Agencies

- Officers assisted rescue at Old School for a person who fell on the ice in parking lot C. Person refused transport.
- Officers assisted rescue at Wright Woods for a runner that had slipped on the ice. Person refused transport.
- Officers assisted rescue at Independence Grove for an employee not feeling well. Employee transported by rescue.
- Officers assisted Lake County Sheriff with a traffic crash at Rte. 45 and Rollins Rd.
- Officers assisted rescue at Ryerson where a patron fell and injured their face. Victim transported by rescue.

Crime Reports

- Officers received a report of a car window being broken at Prairie Wolf DEA. Nothing taken from the vehicle.
- Officers received a report of car burglaries at Buffalo Creek, Prairie Wolf, McDonald Woods and Ray Lake. In each instance suspects broke a window and a purse was removed from the front seat.
- Officers took a delayed theft report from Greenbelt Cultural Center. Victim reported that she left her phone in a room during a holiday party and it turned up missing.

Service Calls

- Officers handled a verbal altercation between two females at Van Patten Woods. All calmed down and went on their way.
- Officers removed a fort from the Des Plaines River Trail near the water plant.
- Officers checked out a suspicious male sleeping in a car at Sun Lake. Subject homeless and catching some sleep.
- Officers located a suspicious intoxicated person at Independence Grove Lot D after Lake County asked for assistance with a possible home invasion. The drunken male had entered a house of an older person and scared them before leaving and entering Independence Grove.
- Officers received a report of a truck off road at Dutch Gap. Vehicle gone upon officer's arrival.
- Officers responded to shots fired at Raven Glen. Neighbors were target shooting on their own property.
- Officers checked out illegal dumping at Fort Sheridan. Debris dumped along the cemetery drive. Debris removed by maintenance.

Encroachments

- **Grassy Lake:** neighbor pumping liquids out of his septic tank towards the preserve. Pump was shut down and the health department notified.
- **Grassy Lake:** Three locations have mowing and one has a possible septic field on District property. Officer requested a survey and will follow up upon completion.
- **Pine Dunes:** Owner of neighboring house given second warning to remove brick walkway to the trail. Citation will be issued in five days if non-compliant.
- **Prairie Wolf:** Neighbor mowing and dumping debris. Officer dealt with the same issue five years ago. Follow up will include warnings and signs posted.
- **Rollins Savanna:** Officer wrote written warnings to two neighbors who have failed to comply with the removal of junk and debris, as well as, mowing and planting. Follow up will include citations.
