



Public Safety Monthly Report

January 20, 2016 – February 17, 2016

Accidents

- Officers investigated two incidents of damaged fencing at Rollins Savanna. Both incidents are the result of earlier accidents reported to Lake County Sheriffs.
- Officers investigated vehicle in snow bank at Old School. Vehicle removed from snow bank; no damage observed.
- Officers are investigating a hit and run accident at Independence Grove where a vehicle knocked down a light pole. Officers are reviewing video and contacting the event host to locate the suspects.

Alarms

- Officers responded to 10 activated burglar alarms during this period.

Arrests

- Officers investigated a dog bite report at Prairie Wolf where one owner pulled out a pellet gun and then left the area. Officers located the owner and arrested him for displaying the pellet gun.
- Officers arrested a driver at Grant Woods for Driving with a Suspended Driver’s License.
- Officers arrested driver at Lyons Woods for Driving with Suspended Driver’s License and Possession of Cannabis.
- Officers arrested a driver at Old School for Possession of Cannabis and other traffic violations.

Assist Other Agencies

- Officers assisted Lindenhurst PD with a complaint of damage to property caused by a contractor driving through a back yard at McDonalds Woods. Officer located the contractor and brought them back to the scene and resolved the issue.
- Officers assisted rescue at Rollins Savanna for patron who fell on ice. Rescue transported the patron for treatment.
- Officers assisted rescue at the Independence Grove Visitor Center for a patron that passed out at an event. Rescue transported the patron for treatment
- Officers assisted rescue at Hastings Lake for patron who fell on trail. Rescue transported the patron for treatment.
- Officers assisted Kenosha County for a vehicle in a ditch on State Line Road across from Dutch Gap. Kenosha Sheriff removed the vehicle.
- Officers located and intoxicated driver wanted by Lake County Sheriffs on Rte. 176 at the entrance to Lakewood. Driver turned over to Lake County Sheriff for processing.
