**FINANCIAL DATA:** These payments for services were approved as part of the adopted FY 2015/16 Budget in the amount of \$139,760.00. The actual cost of \$139,764.54 will be charged to various organization codes and object code 708900.

**BACKGROUND:** Lake County provides various services to the Forest Preserve District for which the District compensates the County. The County invoices us annually for these services as follows:

**A RESOLUTION AUTHORIZING PAYMENT OF \$139,764.54  
TO LAKE COUNTY FOR SERVICES**

**WHEREAS**, the Lake County Forest Preserve District, Lake County, Illinois (the “District”) has requested that certain administrative services (the “Services”) be provided by Lake County, Illinois (the “County”), which are described in more detail below; and

**WHEREAS**, the District has elected to use the County’s payroll software system to process payroll for District employees and provide administrative services to process health, life, and dental benefits; and

**WHEREAS**, the District has requested that the County provide various information technology support services; and

**WHEREAS**, the District uses the County Board Room for District Board meetings, which the District wishes to have televised for broadcast over the cable TV system and for webcasting; and

**WHEREAS**, the District has requested the use of County radio dispatch services and other communication services related to operation of the District Public Safety Division; and

**WHEREAS**, it is in the best interest of the District to compensate the County in the total amount of \$139,764.54 for the Services and the District has appropriated the necessary funds for such payment in the current budget; and

**WHEREAS**, pursuant to Article VII, Section 10 of the Illinois Constitution, units of local government, such as the District and the County, may associate among themselves to obtain or share services and to exercise, combine, or transfer any power or function, in any manner not prohibited by law; and

**WHEREAS**, pursuant to Section 3 of the Illinois Intergovernmental Cooperation Act, 5 ILCS 220/3, any power, privilege, function, or authority exercised by one public agency, such as the District or the County, may be exercised, combined, transferred, and enjoyed jointly with any other public agency; and

**WHEREAS**, the District’s Purchasing Manager has determined, and the Board of Commissioners hereby finds, that the County is the sole supplier of the Services;

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners of the Lake County Forest Preserve District, Lake County, Illinois, **THAT**:

Section 1: Recitals. The recitals set forth above are incorporated as part of this Resolution by this reference.

Section 2: Payments. The District Treasurer is hereby authorized and directed to pay \$139,764.54 to the County for the Services.

Section 3: Effective Date. This Resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.
