RECOMMENDATION: Recommend approval of a Resolution awarding a Contract for the Everett Road Trail Connection Construction at Captain Daniel Wright Woods Forest Preserve to V3 Construction Group, Ltd., Woodridge, Illinois, in the Contract Price of \$924,260.00.

STRATEGIC DIRECTION SUPPORTED: Public Access and Connection

FINANCIAL DATA: This project was approved as part of the adopted FY2016/2017 Capital Improvement Plan in the amount of \$1,500,000.00. This portion of the project was estimated at \$1,334,183.04. The actual cost of \$924,260.00 will be charged to account 35304100-803400-65101.

BACKGROUND: The proposed Everett Road Trail will provide an important connection linking the existing Des Plaines River Trail at Captain Daniel Wright Woods Forest Preserve to the Lake County Division of Transportation's (LCDOT) existing bike path and the existing Lincolnshire bike path located at the intersection of Everett and Riverwoods Roads. LCDOT has informed the District that it plans to redesign Everett Road at the location of the District's planned crosswalk. This will create a short-term gap in the trail. The gap will be designed and built in partnership with LCDOT as part of the future improvements to Everett Road.

The project was advertised on July 7, 2016 and six bids were received. A summary of the bids received is listed below:

Copenhaver Construction Co., Inc. submitted the lowest bid. However, Copenhaver, Construction Co., Inc. has sent a letter requesting the withdrawal of its bid due to a mistake in the unit price listed for a portion of the work. Staff recommends that Copenhaver Construction, Co., Inc. be allowed to withdraw its bid.

After reviewing the bids and relevant information, including references, staff recommends that V3 Construction Group. Ltd. be awarded the contract as the lowest responsible bidder.

Work is anticipated to begin September 27, 2016 and be completed by June 30, 2017.

<u>Section 4:</u> <u>Execution of Contract.</u> The Executive Director of the District is hereby authorized and directed to execute the Contract for the Work in the amount of the Contract Price.
