**FINANCIAL DATA:** The District budgeted \$41,000 in FY16/17 for Occupational Health Services in account 23104000-707200.

**BACKGROUND:** In November 2013, the District entered into a two-year contract with Advocate Health Care for Occupational Health Services. In November 2015, the District amended the contract to allow the District to exercise three (3) one-year renewal periods. In November 2015, the District exercised the first of the three one-year renewal periods. At this time, the District wishes to extend the contract a second time, through October 31, 2017.

**A RESOLUTION EXTENDING THE CONTRACT WITH ADVOCATE HEALTH CARE  
FOR OCCUPATIONAL HEALTH SERVICES FOR ONE YEAR**

**WHEREAS**, on November 1, 2013 the Lake County Forest Preserve District (the "District") has awarded a contract to Advocate Health Care for Occupational Health Services (the "Contract"); and

**WHEREAS**, the District wishes to extend the Contract for an additional one-year term, commencing November 1, 2016 and lasting through October 31, 2017 (the "Extension");

**WHEREAS**, pursuant to the Contract, the District may extend the Contract for two additional one-year terms, the first being November 1, 2017 through October 31, 2018 and the second being November 1, 2018 through October 31, 2019 (the "Future Extensions");

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners of the Lake County Forest Preserve District, Lake County, Illinois THAT:

**Section 1. Recitals.** The recitals set forth above are incorporated as part of this Resolution by this reference.

**Section 2. Approval of Extension.** The Extension is hereby approved.

**Section 3. Execution of Contract; Future Extensions.** The Executive Director and Secretary of the District are hereby authorized to execute and attest to the Extension on behalf of the District. The Executive Director is hereby authorized to approve the Future Extensions on behalf of the District.

**Section 4. Payments.** The District Treasurer shall make payments under the Contract only pursuant to and in accordance with the Contract terms.

**Section 5. Effective Date.** This Resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.
