**RECOMMENDATION:** Approve a motion to accept new donations to the Lake County Discovery Museum's historic collections listed on the attached Acquisitions Inventory.

**STRATEGIC DIRECTION SUPPORTED:** Communication, Education, and Outreach

**FINANCIAL DATA:** There is no financial impact associated with accepting these donations.

**BACKGROUND:** The Lake County Discovery Museum "collects material culture representing the people, places, and events of Lake County, Illinois" (Collections Policies, Scope of Collections, p. 4). The majority of the Museum's historic collection were acquired by the County of Lake from the privately run Lake County Museum of History in 1965 for the purpose of "preserv(ing) and maintain(ing) for future generations the cultural history of Lake County" (Resolution No. 24, dated October 12, 1965). These collections were officially transferred to the Lake County Forest Preserve District in 1989.

The Museum is frequently offered donations by members of the general public. Each donation is considered against established criteria stated in the Museum's collections policies. Donations that do not meet these criteria are declined. Since July 2015 the museum has received 49 donation inquiries of which 30 were declined. Examples of declined donations included a shipwreck remnant found on a beach near North Chicago (the Museum is unable to store, preserve or maintain this item) and Native American stone points that were collected in the West (the items do not have a direct relationship to Lake County, IL).

The donations listed on the attached Acquisitions Inventory are being recommended by staff for acceptance into the museum's historic collections, because they are material culture representing the people, places, and events of Lake County, Illinois.
