RECOMMENDATION: Recommend approval of a Resolution approving the deaccession of out-of-scope armament items from the Museum's collections and offer the items for sale at public auction.

STRATEGIC DIRECTION SUPPORTED: Organizational Sustainability

FINANCIAL DATA: There is no cash outlay for this project. Proceeds from the sale of the out-of-scope items, by policy, can only be used for the acquisition or care and preservation of Museum collections.

BACKGROUND: In preparation for the relocation of the Lake County Discovery Museum to the General Offices in Libertyville, staff has been conducting inventories of the Museum's historic collections. As part of this process the District contracted with Great American Antiques in October 2015 to conduct an inventory/appraisal of the Museum's armament collection.

The Museum's armament collection consists of firearms and edged weapons including bayonets, muskets, pistols, rifles, shotguns, and swords. During the inventory, each item was fully inspected and cataloged. Firearms were characterized by type, manufacturer, manufacture date, serial numbers, model, and caliber. Detailed descriptions were provided for every item including a possible value (low and high range) if the District decides to deaccession and auction any out-of-scope items.

After receiving the final inventory/report in January 2016, Museum staff compared every item against the collection database to determine known provenance at the item level. After careful analysis of the entire armament collection, the Museum's Collections Committee is recommending that the 413 items in Exhibit A be deaccessioned and sold at public auction. These items have been determined to have either no known relationship to Lake County, be in poor condition, or have no future benefit to the Museum for preservation, scholarly research, or exhibition.

All funds received through the sale of materials from the auction of out-of-scope objects will be used only for the acquisition, care, and preservation of collections as mandated by the District's Collections Policies and professional standards set forth by the American Association of Museums.

**A RESOLUTION APPROVING THE DEACCESSION AND CONVEYANCE
OF OUT-OF-SCOPE ARMAMENT ITEMS FROM
THE LAKE COUNTY DISCOVERY MUSEUM'S COLLECTIONS**

WHEREAS, the Lake County Forest Preserve District (the "District") owns and operates the Lake County Discovery Museum (the "Museum"); and

WHEREAS, the Museum's collections include an armament collection owned by the District and consisting of firearms and edged weapons including bayonets, muskets, pistols, rifles, shotguns, and swords (the "Collection"); and

WHEREAS, 413 items from the Collection are identified on Exhibit A attached hereto (the "Items"); and

WHEREAS, the District manages the Items according to the Museum's Collections Policies (the "Policies"), which states that items in the Museum's Lake County collections shall consist of material that have significant historical relevance to Lake County, are in good physical condition, and do not duplicate other items in the collections; and

WHEREAS, pursuant to the Policies, the Museum's Collections Committee, the District's Superintendent of Educational Facilities, the District's Education, Cultural Resources and Public Affairs Committee, and the District's Finance and Administrative Committee have recommended that the District deaccession and sell or otherwise dispose of the Items; and

WHEREAS, pursuant to Section 8(d) of the Downstate Forest Preserve District Act, 70 ILCS 805/0.001 et seq., whenever the District owns any personal property that is no longer necessary, useful to, or for the best interests of the District, then three-fifths of the members of the District's Board of Commissioners, by an ordinance or resolution, may authorize the conveyance or sale of that personal property in any manner that they may designate; and

WHEREAS, the Board of Commissioners hereby finds that the Items are surplus and that it is no longer necessary, useful to, or in the best interests of the District to retain ownership of the Items; and

WHEREAS, it is in the best interest and serves the purposes of the District to deaccession and sell or otherwise dispose of the Items;

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of the Lake County Forest Preserve District, Lake County, Illinois **THAT**:

Section 1. Recitals. The recitals set forth above are incorporated as a part of this Resolution by this reference.

Section 2. Deaccession and Sale of Items. The District hereby deaccessions the Items. The Executive Director, or his designee, is hereby authorized to cause the Items to be auctioned "as is" and to discard any Items for which no suitable bids are received.

Section 3. Effective Date. This Resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.
