FINANCIAL DATA: This expenditure was approved as part of the adopted FY2016/17 Budget as part of the Museum Relocation Project. This portion of the project was estimated at \$50,000.00. The actual cost of \$64,500.00 will be charged to Account 11104100-803100-61811.

BACKGROUND: In preparation for moving the Museum to the General Office, the District solicited bids for the construction of a new front entry and vestibule. This new entryway replaces and old deteriorating entrance while also addressing ADA requirements for access to the building and Museum.
