**RECOMMENDATION:** Recommend approval of a Resolution awarding a Contract for the purchase of access control and video surveillance equipment and services to Computer Power Systems, LLC, of Grayslake, IL, with the total purchase price of \$53,710.00.

STRATEGIC DIRECTION SUPPORTED: Organizational Sustainability.

**FINANCIAL DATA:** Funding for General Offices security enhancements was approved as part of the adopted FY2017/18 budget in account 23104100-809000 in the amount of \$66,000.00.

**BACKGROUND:** As part of the overall improvements to the general offices the District will purchase and install eight access-control door controllers with associated equipment and wiring and ten video surveillance cameras with associated equipment and wiring throughout the first floor and exterior of the building, along with a network video recorder and software licenses. The purchase includes a 12-month equipment and 90-day labor warranty on all materials.

## A RESOLUTION AWARDING A CONTRACT FOR ACCESS CONTROL AND VIDEO SURVEILLANCE SYSTEM AND SERVICES TO COMPUTER POWER SYSTEMS, LLC

**WHEREAS**, the Lake County Forest Preserve District (the "District") desires to purchase door access controls, video surveillance cameras, a network video recorder, software licensing, and related installation services (the "Equipment and Services"); and

**WHEREAS**, the Director of Administration and the Purchasing Manager have determined that the Equipment and Services require personal confidence; and

**WHEREAS**, the Information Technology Officer has solicited a proposal for the Equipment and Services from Computer Power Systems, LLC; and

WHEREAS, the District's staff, the Purchasing Manager, the Director of Administration and the Finance Director have reviewed the proposal and recommend that the Board of Commissioners (i) find that the proposal submitted by Computer Power Systems, LLC, be determined to be the proposal that is most advantageous to the District; and (ii) award a contract for the Equipment and Services to Computer Power Systems, LLC. (the "Contract") in the amount of \$53,710.00 (the "Contract Price"); and

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners of the Lake County Forest Preserve District, Lake County, Illinois, **THAT**:

**Section 1: Recitals.** The recitals set forth above are incorporated as a part of this Resolution by this reference.

Please review the following video surveillance and access control proposal for the GO Building:

## Scope of work:

#### Video Surveillance -

- Provide and install (1) Plenum Category 6 data cable from the nearest IC to (4) Exterior, IP, camera locations. These are located at the corners of the buildings at the 3<sup>rd</sup> floor level due to trees.
- Provide and install (1) Plenum Category 6 data cable from the nearest IC to (2) Exterior, IP, camera locations on the South side of building. These care located at the 2<sup>nd</sup> floor level to the inside edge of the existing trees.
- Provide and install (1) Plenum Category 6 data cable from the nearest IC to (4) Interior, IP, camera locations on the 1<sup>st</sup> floor. (2x cameras in the Visitor lobby, 1x in the employee lobby, and 1x covering the bathroom hall)
- ☐ Terminate all Category 6 cables to a RJ45 Category 6 orange jack at the location end.
- ☐ Terminate all Category 6 cables to an available port on a Category 6 patch panel.
- Provide and install a cable support system as necessary.
- □ Provide (10) Category 6, 5' IC patch cables and (10) Category 6, 10' location patch cords.
- Provide and install (1) Axis, 4x2mp lens, Exterior camera w/ required corner mounting hardware and seal-tight outdoor flex conduit (as required) at the (4) primary corners of the building at the 3<sup>rd</sup> floor height due to trees blocking line of site along building.
- Provide and install (1) Axis, 2mp, exterior camera w/ LED IR at (2) locations on the South side of building to the left and right of the main entrance at the 2<sup>nd</sup> floor height.
- Provide and install (1) Axis, 2mp, interior wide angle camera at (2) locations in the opposite corners over-watching the front door and side doors.
- □ Provide and install (1) Axis, 2mp, interior wide angle camera at (1) location over-watching the back entrance, committee room & back hallway.
- Provide and install (1) Axis, 2mp, interior wide angle camera at (1) location over-watching the bathroom towards the front entrance.
- Provide and install (1) NUUO, Network Video Recorder w/ (8) 4TB HDD configured at RAID 5 and slide rail for server rack. (NVR comes with 16 IP camera licenses; expandable to 64)
- \*\* is required for V/S system to work. This platform cannot be put on a separate machine / server. \*\*
- \*\* No reoccurring yearly fees required for licenses. Just a new license when you add a camera above the preloaded 16 licenses.\*\*
- Provide IT labor to program video surveillance system to customer required access levels, view configurations, and recording times.
- Provide training (approx. 2hrs) and load client software on (3) customer devices.
  - Provide (1) Boom lift rental for 1-week for the installation of the cameras on outside of building.
- All work will be performed in a neat and professional manner. Testing will be performed and documentation will be provided after completion of project.

- Provide and install (1) Plenum Access Control composite cable from basement A/C wiring center to (8) stairwell door locations. These are located in the East & West stairwell from the basement to the 3<sup>rd</sup> floor.
- Provide and install (1) Plenum Category 6 data cable from the network in the A/C wiring center to the A/C backboard for (8) Access Control controllers.
- □ Provide and install (8) Conduit back-boxes for the controllers.
- □ Terminate all Category 6 cables to a RJ45 Category 6 plug at the location end.
- ☐ Terminate all Category 6 cables to an available port on a Category 6 patch panel.
- Provide and install a cable support system as necessary.
- □ Provide (8) Category 6, 3' IC patch cables.
- Provide and install (1) Access Control controller for (7) stairwell doors. (LCFP has 1x controller on hand that will be used for the 8<sup>th</sup> door)
- Provide and install (1) HID Access Control reader, similar to existing, at (6) stairwell doors. (LCFP has 2x readers on hand that will be used for doors 7 and 8)
- Provide and install (1) IR motion REX at (5) stairwell doors. (LCFP has 3x IR motion REX's on hand that will be used for doors 6, 7, & 8)
- Provide and install (1) Door contact at (6) stairwell doors. (LCFP has 2x door contacts on hand that will be used for doors 7 & 8)
- Provide and install (1) Electric strike at (6) stairwell doors. (LCFP has 2x electric strikes on hand that will be used for doors 7 & 8)
- Provide and install (1) Maximal 7, 24v DC, electric strike / motion REX power supply.
- All work will be performed in a neat and professional manner. Testing will be performed and documentation will be provided after completion of project.

- Provide and install (1) Axis, 2mp, exterior camera w/ LED IR at (1) location on the East side of building for the dock.
- Provide and install (1) NUUO video, small form, client station box.
- Provide and install (1) 22" HP Monitor w/ HDMI input and wall mount bracket at designated reception desk location for V/S monitoring.
