**RECOMMENDATION:** Recommend approval of a Resolution Awarding a Two-Year Contract for turf mowing to Grundstrom Landscape Maintenance, Mundelein, Illinois for the Fort Sheridan Cemetery, Heron Creek Forest Preserve and Van Patten Woods Forest Preserve in an amount not to exceed \$68,500.00 (\$34,250.00 annually).

### **STRATEGIC DIRECTION SUPPORTED:** Organizational Sustainability

**FINANCIAL DATA:** The first year of this expenditure has been approved in the adopted FY2017-2018 Budget in the total amount of \$35,300.00 (\$25,300.00 in 15524000-705100 for Heron Creek and Van Patten Woods and \$10,000.00 in 27614000-709000 for Fort Sheridan Cemetery). Future year budget requests will be based on the contract amount for year two.

**BACKGROUND:** Beginning with Independence Grove in 2000, as the District developed and opened more recreational space, some portion of the mowing and landscape maintenance required has been outsourced to private vendors. This practice has reduced the District's need to hire staff and buy and maintain equipment. The existing maintenance contracts for Fort Sheridan Cemetery, Heron Creek Forest Preserve and Van Patten Woods Forest Preserve have expired and need to be reissued. The District solicited bids for all three sites.

A summary of the low bidders for each site is included on Exhibit A attached to the Resolution. After reviewing the bids and relevant information, including references, staff recommends that Grundstrom Landscape Maintenance be awarded a contract as the lowest responsible bidder for the Fort Sheridan Cemetery, Heron Creek Forest Preserve and Van Patten Woods Forest Preserve sites.

#### A RESOLUTION AWARDING A CONTRACT FOR TURF MOWING TO GRUNDSTROM LANDSCAPE MAINTENANCE

**WHEREAS**, the Lake County Forest Preserve District (the "District") has advertised in <u>The Lake County News Sun</u> for sealed bids for Turf Mowing for a two-year period at Fort Sheridan Cemetery, Heron Creek Forest Preserve and Van Patten Woods Forest Preserve (the "Work"); and

**WHEREAS,** all sealed bids were received and opened by the District at its Headquarters, 1899 West Winchester Road, Libertyville, Illinois on October 27, 2017 at 10:00 a.m.; and

WHEREAS, bids were received in the amounts set forth in Exhibit A attached hereto; and

**WHEREAS,** the District's staff; the Purchasing Manager; the Director of Operations and Infrastructure; and the Operations and Finance Committees have reviewed the bids and recommend that the Board of Commissioners find Grundstrom Landscape Maintenance to be the lowest responsible bidder for the Work; and

**WHEREAS**, the Board of Commissioners hereby finds Grundstrom Landscape Maintenance is the lowest responsible bidder for the Work;

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners of the Lake County Forest Preserve District, Lake County, Illinois THAT:

- <u>Section 1</u>. <u>Recitals</u>. The recitals set forth above are incorporated as a part of this Resolution by this reference.
- <u>Section 2</u>. <u>Award of Contract</u>. The bids submitted by Grundstrom Landscape Maintenance for the Work (collectively, the "Contract Price") is hereby accepted and a Contract for the Work is hereby awarded to Grundstrom Landscape Maintenance.
- <u>Section 3</u>. <u>Execution of Contract</u>. The Executive Director of the District is hereby authorized and directed to execute the Contract for the Work in the amount of the Contract Price.
- <u>Section 4.</u> <u>Payments</u>. The Treasurer shall make payments under the Contract only pursuant to and in accordance with the Contract terms.

<u>Section 5</u>. <u>Effective Date</u>. This Resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.
