**RECOMMENDATION:** Recommend approval of a Resolution awarding a Contract for the Purchase of two 2018 Toyota Prius 2, Model #1223 Hybrid Sedans from National Auto Fleet Group, Watsonville, California, in an amount not to exceed \$48,926.24 (\$24,463.12 each).

#### STRATEGIC DIRECTION SUPPORTED: Organizational Sustainability

**FINANCIAL DATA:** These vehicles were approved for replacement as part of the adopted FY2017/18 Vehicle Replacement Fund Budget (90104100-804100). The total budgeted amount for the vehicles is \$54,000.00 (\$27,000.00 each).

**BACKGROUND:** In accordance with the District's Vehicle Replacement Schedule, District staff determined that two 2006 Toyota Prius Hybrid Sedans (Units 40 and 42) are due for replacement.

Staff publicly advertised for bids for two 2018 Prius 2 sedans, with bids due December 18, 2017. No bids were received.

Having received no bids, staff investigated a bid from the National Auto Fleet Group, submitted to the cooperative National Joint Purchasing Alliance (NJPA), and accepted by NJPA pursuant to its contract 120716-NAF. Pursuant to the Illinois Governmental Joint Purchasing Act, 30 ILCS 525/1 et. seg., the District may purchase the vehicle under a contract that was bid and awarded to the National Auto Fleet Group by the NJPA, in accordance with the Act.

The new vehicles are expected to be in service for ten (10) years or 120,000 miles per the District's vehicle replacement guidelines.

#### A RESOLUTION AWARDING A CONTRACT TO NATIONAL AUTO FLEET GROUP FOR THE PURCHASE OF TWO VEHICLES

WHEREAS, the Lake County Forest Preserve District (the "District") desires to purchase two new 2018 Toyota Prius 2 Vehicles (the "Vehicles"); and

WHEREAS, pursuant to the Illinois Governmental Joint Purchasing Act, 30 ILCS 525/1, et seq., any governmental unit may purchase personal property, supplies, and services jointly with one or more other governmental units if one of the governmental units has publicly advertised for, and received, competitive, sealed bids or proposals, and has awarded a contract for such personal property, supplies, and services to the lowest responsible bidder or the highest ranking proposer, all in accordance with such Act; and

WHEREAS, the National Joint Powers Alliance has publicly advertised, and received, competitive sealed bids for a contract for the Vehicles, including a bid from the National Auto Fleet Group in the amount of \$48,926.24 for two Vehicles; and

WHEREAS, the National Joint Powers Alliance has awarded a contract, numbered 120716-NAF, for the Vehicles to National Auto Fleet Group as the lowest responsible bidder (the "NJPA Contract"), and has made the NJPA Contract available to other public entities; and

WHEREAS, it is in the best interest of the District to award a contract for the two Vehicles to National Auto Fleet Group (the "Contract") in a total price equal to \$48,926.24 (the "Contract Price");
