**RECOMMENDATION:** Recommend approval of a Resolution awarding a Contract for Public Access Improvements at Ethel’s Woods Forest Preserve to Campanella & Sons, Wadsworth, Illinois, in the Contract Price of \$824,522.45.

**STRATEGIC DIRECTION SUPPORTED:** Public Access and Connections

**FINANCIAL DATA:** This project was approved as part of the adopted FY2017/2018 Capital Improvement Plan in the amount of \$1,000,000.00. This portion of the project was estimated at \$1,000,000.00. The actual cost of \$824,522.45 will be charged to account 35304100-803200-63901.

**BACKGROUND:** In 2002, the District received an Open Lands Trust grant from the Illinois Department of Natural Resources to partially fund the purchase of Ethel’s Woods Forest Preserve. As part of the grant agreement, the District agreed to design and construct public access improvements including a parking area, toilet, loop trail and scenic overlooks. These improvements are required to be completed and open to the public by the end of 2019.

The improvements include a new entrance drive from Miller Road leading to a 25-car parking lot with a prefabricated single-unit evaporator toilet building, a 0.7-mile section of the Millennium Trail, a 0.7-mile crushed stone loop trail and three informal overlooks. The additional segments of the planned Millennium Trail at Ethel’s Woods will be completed through separate projects and contracts when funding becomes available.

The project was advertised on November 27, 2017 and eight (8) bids were received. A summary of the bids received is listed below:

**WHEREAS**, the District's staff, the Purchasing Manager, the Director of Planning and Land Preservation, and the Planning Committee have reviewed the bids and recommend that the Board of Commissioners find Campanella & Sons, Inc. to be the lowest responsible bidder and award a contract for the Work to Campanella & Sons, Inc. (the "Contract"); and

**WHEREAS**, the Board of Commissioners hereby finds that Campanella & Sons, Inc. is the lowest responsible bidder for the Work;

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners of the Lake County Forest Preserve District, Lake County, Illinois, **THAT**:

**Section 1: Recitals.** The recitals set forth above are incorporated as part of this Resolution by this reference.

**Section 2: Award of Contract.** The bid submitted by Campanella & Sons, Inc. in the amount of \$824,522.45 (the "Contract Price") is hereby accepted and a Contract for the Work is hereby awarded to Campanella & Sons, Inc.

**Section 3: Execution of Contract.** The Executive Director of the District is hereby authorized and directed to execute the Contract for the Work in the amount of the Contract Price.

Section 4: Payments. The District Treasurer shall make payments under the Contract only pursuant to and in accordance with the Contract terms.

Section 5: Effective Date. This Resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.
