**RECOMMENDATION:** Recommend approval of a Resolution awarding a Contract for the Invasive Plant Management 2018 at Middlefork Savanna Forest Preserve to McGinty Bros., Inc., Long Grove, Illinois, in the Contract Price of \$46,200.00.

#### STRATEGIC DIRECTION SUPPORTED: Conservation

FINANCIAL DATA: This item was approved as part of the adopted FY2017/2018 Budget in the amount of \$50,000.00. The actual cost is \$46,200.00. Of the actual cost, \$23,100.00 will be charged to the Farm Management Fund (2864400-705100-62803) and \$23,100.00 will be charged to the Reforestation Fund (20104100-803200-60008).

BACKGROUND: Middlefork Savanna Forest Preserve contains many examples of high quality oak savanna, prairie, and wetland habitats. The work of this project will provide seasonlong invasive plant control to the entire site.

The project was advertised on December 28, 2017 and six bids were received. A summary of the bids received is listed below:
