RECOMMENDATION: Recommend approval of a Resolution approving Change Order Number Six to the Contract with Sentry Security, LLC, for District-wide Fire and Security Alarm Monitoring, Maintenance, Repair and Testing Services.

STRATEGIC DIRECTION SUPPORTED: Organizational Sustainability.

FINANCIAL DATA: This Change Order will increase the cost of the existing contract with Sentry Security by \$1,236.00 annually. There will also be a one-time installation fee of \$3,997.00. Funds for Fire and Security Alarm monitoring, maintenance, repair and testing services are found in account 23104000-704900.

BACKGROUND: On March 10, 2015, the District entered into a two-year contract with Sentry Security, LLC, for District-wide Fire and Security Alarm monitoring, maintenance, repair and testing services. The contract includes up to three additional one-year terms that can be exercised by the District. The District has exercised two of these three options to date.

Over the last three years, the District has approved five change orders to the contract, including, on October 13, 2015, to approve the installation of Security (burglar) Alarms at the Operations and Public Safety building and the associated costs for monitoring and inspection services. Change order number 6 would amend the Schedule of Services to include the installation (\$3,997.00) of Security and Fire Alarms and the associated cost for monthly monitoring and annual inspections (\$1,236.00) at the Pine Dunes' Wildlife Center.

Change Orders that, when added to all prior change orders to a contract, exceed 20% of the contract price or \$20,000, whichever is less, must be approved by the Board. Because of the cumulative cost of the prior change orders, the 20%/\$20,000 allowance was exceeded, requiring Board approval of Change Order Number Six.

WHEREAS, the Lake County Forest Preserve District (the "District") and Sentry Security, LLC (the "Consultant") entered into a contract (the "Contract") for the performance by the Consultant of fire alarm and security alarm monitoring, maintenance, and testing services at various District facilities (the "Services"); and

WHEREAS, the specific Services that the Consultant must perform at each District facility, and the compensation the District agreed to pay the Consultant for such Services, are set forth in Section 6.A of Attachment A attached to the Contract, in the table titled "Monitoring, Maintenance, and Testing Fees Per Location" (the "Schedule of Services"); and

WHEREAS, on April 26, 2016 the District and the Consultant approved Change Order Number Three to the Contract ("Change Order No. 3") which allowed Sentry to process payments to Tyco Integrated Security for fire alarm monitoring at the Archives building as well as \$1.00 increases at four other District sites (\$344.62); and

WHEREAS, on March 2, 2017 the District and the Consultant approved Change Order Number Four to the Contract ("Change Order No. 4") for the removal of fire testing fees at various sites (\$-660.00); and

WHEREAS, on September 1, 2017 the District and the Consultant entered into Change Order Number Five to the Contract ("Change Order No. 5") which increased fees at six District sites due to the change from phone lines to radio equipment (\$1,140).; and

WHEREAS, the District and the Consultant desire to further amend the Schedule of Services to provide Services at Pine Dunes Wildlife Center as provided in Change Order Number Six attached hereto ("Change Order No. 6");

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Lake County Forest Preserve District, Lake County, Illinois **THAT**:

Wiring will be to 14 heat detectors (in a loop), 2 overhead doors, 2 sliding doors, 1 pedestrian door and 1 keypad near the back pedestrian door. Wire will need to be in a junction box at each device location and wire needs to be brought down into the alarm panel (on the other end). All wires must be labeled as to what they are for. A drawing will be provided identifying device locations.

Some parts on the system are existing (keypads, heat detectors in the house, wireless receiver and all wiring to these devices) They are assumed to be good and defect free. If they are not, additional cost will apply to replace or repair such.

Burglar alarm panel, cellular communicator, arming keypads, wireless receiver unit, wireless door contacts, wireless motion detectors, hardwired overhead door contacts, hardwired heavy duty sliding door contacts, residence smoke detectors and residence heat detectors.

Change Order Number Six to Contract Between Lake County Forest Preserve District and Sentry Security, LLC For District-Wide Fire and Security Alarm Monitoring, Maintenance, Repair, and Testing Services

THIS CHANGE ORDER NUMBER SIX ("Change Order No. 6"), dated as of April 10, 2018, to that certain Contract for District-Wide Fire and Security Alarm Monitoring, Maintenance, Repair, and Testing Services, dated as of March 10, 2015 ("Contract"), between the LAKE COUNTY FOREST PRESERVE DISTRICT, a body politic and corporate organized and existing under the Downstate Forest Preserve District Act, 70 ILCS 805/.001 et seq., ("District"), and SENTRY SECURITY, LLC, an Illinois limited liability company ("Consultant").

RECITALS

WHEREAS, the District and the Consultant entered into the Contract for the performance by the Consultant of fire alarm and security alarm monitoring, maintenance, and testing services at various District facilities (the "Services"); and

WHEREAS, the specific Services that the Consultant must perform at each facility are set forth in Section 1 of Attachment A attached to the Contract and in Attachment B to the Contract (the "Scope of Work"), and the compensation the District agreed to pay the Consultant for such Services, is set forth in Section 6.A of Attachment A attached to the Contract, in the table titled "Monitoring, Maintenance, and Testing Fees Per Location" (the "Schedule of Services"); and

WHEREAS, on October 1, 2015, the District and the Consultant entered into Change Order Number One to the Contract ("Change Order No. 1"), which amended the Schedule of Services (referred to in Change Order No. 1 as "Exhibit A") to modify the Services performed at certain District facilities and the prices charged for those Services; and

WHEREAS, on November 16, 2015, the District and the Consultant entered into Change Order Number Two to the Contract ("Change Order No. 2"), which amended the Schedule of Services (referred to in Change Order No. 2 as "Exhibit A") to modify the Services performed at certain District facilities and the prices charged for those Services; and

WHEREAS, on April 26, 2016 the District and the Consultant entered into Change Order Number Three to the Contract ("Change Order No. 3") which amended the Schedule of Services (referred to in Change Order No. 3 as "Exhibit A") to modify the Services performed at certain District facilities and the prices charged for those Services; and

WHEREAS, on March 2, 2017 the District and the Consultant entered into Change Order Number Four to the Contract ("Change Order No. 4") which amended the Schedule of Service (referred to in Change Order No. 4 as "Exhibit A") to modify the Services performed at certain District facilities and the prices charged for those Services; and

WHEREAS, on September 1, 2017 the District and the Consultant entered into Change Order Number Five to the Contract ("Change Order No. 5") which amended the Schedule of Service (referred to in Change Order No. 4 as "Exhibit A") to modify the Services performed at certain District facilities and the prices charged for those Services; and

WHEREAS, the District and the Consultant desire to further amend the Scope of Work and Schedule of Services by adding Services for the Pine Dunes Wildlife Center (24A on "Exhibit A"), including a one-time installation fee of \$3,997.00 and ongoing monthly monitoring and annual testing fees totaling \$1,236.00 per year, and

NOW, THEREFORE, in consideration of the mutual covenants set forth in this Change Order No. 6, the receipt and sufficiency of which are hereby acknowledged, the District and the Consultant agree as follows:

SECTION 1. RECITALS.

The foregoing recitals are hereby incorporated into, and made a part of, this Change Order No. 6 as if fully set forth herein.

<u>SECTION 2.</u> <u>DEFINITIONS; RULES OF CONSTRUCTION</u>.

- A. <u>Definitions.</u> All capitalized words and phrases used in this Change Order No. 6 have the meanings set forth in the various provisions of this Change Order No. 6. If a word or phrase is not specifically defined in this Change Order No. 6, it has the same meaning as in the Contract.
- **B.** Rules of Construction. Except as specifically provided in this Change Order No. 6, all terms, provisions and requirements contained in the Contract remain unchanged and in full force and effect. In the event of a conflict between the text of the Contract and the text of this Change Order No. 6, the text of this Change Order No. 6 controls.

SECTION 3. AMENDMENT TO SCHEDULE OF SERVICES.

The Scope of Work is hereby amended by adding to Attachment B to the Contract the description of work and pricing in the attached proposal from Consultant dated February 27, 2018. The Schedule of Services, as amended by Change Order No. 5 to the Contract, is hereby deleted in its entirety and replaced with Exhibit A attached to and, by this reference, made a part of this Change Order No. 6. All references in the Contract to the information contained within the Scope of Work and Schedule of Services shall hereafter be deemed to refer to the information contained within Attachment B (as amended) and Exhibit A attached to this Change Order No. 6.
