RECOMMENDATION: Recommend approval of a Resolution approving Change Order No. 1 to the agreement with Accountemps for temporary staffing in the Finance Department, increasing the Contract Amount by \$10,844.60.

STRATEGIC DIRECTION SUPPORTED: Organizational Sustainability

FINANCIAL DATA: The Accountant position in the department has been open since December 2017. The salary savings have been used to cover the Accountemps costs.

BACKGROUND: When the accountant position became vacant it became necessary to bring in an outside temporary staff person to keep up with the workload. The department was also reorganized after this and the Accounting Manager position was advertised for replacement. After the first round of interviews a qualified candidate was not found and the position was re-advertised. Because of this delay the temporary position was kept longer than anticipated, thus the need for a change order.

**A RESOLUTION APPROVING CHANGE ORDER NO. 1 TO THE AGREEMENT WITH
ACCONTEMPS FOR TEMPORARY STAFFING**

WHEREAS, the Lake County Forest Preserve District, Lake County, Illinois (the "District") has entered into an agreement with Accountemps (the "Agreement") to provide temporary staffing in the Finance Department (the "Services"); and

WHEREAS, based on current staff needs, the District desires to purchase additional Services (the "Additional Services"); and

WHEREAS, it is in the best interest of the District to approve Change Order No. 1 to the Agreement to provide the Additional Services, in the form attached hereto (the "Change Order");

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Lake County Forest Preserve District, Lake County, Illinois, THAT:

Section 1: Recitals. The recitals set forth above are incorporated as part of this Resolution by this reference.

Section 2: Approval of Change Order. The Change Order, in substantially the form attached hereto, is approved for the following reasons: a) the circumstances necessitating the Change Order were not reasonably foreseeable at the time the Agreement was entered into; b) the Change Order is germane to the original Agreement; and c) the Change Order is in the best interest of the District.

Section 3: Placement in Contract File. This Resolution and the Change Order shall be preserved in the permanent District file of the Agreement. This Resolution shall constitute the written determination required by Section 33E-9 of the Illinois Criminal Code, 720 ILCS 5/33E-9.

Section 4: Reapproval of the Agreement. The Agreement is hereby reapproved, except to the extent that it has been changed by or conflicts with the Change Order or this Resolution.

Section 5: Effective Date. This Resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.


