FINANCIAL DATA: Funding for Bess Bower Dunn Museum security enhancements was approved as part of the adopted FY2018/19 budget for \$39,730.00 in account 14724100-805100.

BACKGROUND: The District will purchase and install 20 security cameras throughout the Bess Bower Dunn Museum as well as door access control at the entrance to the Collection Care and Storage Facility in the General Offices basement. Cameras will be located in the galleries, stairwells and basement hallways. The purchase includes installation, licensing, associated cabling and a 12-month equipment and 90-day labor warranty on all materials.

A RESOLUTION AWARDING A CONTRACT FOR AN ACCESS CONTROL AND VIDEO SURVEILLANCE SYSTEM AND RELATED SERVICES TO COMPUTER POWER SYSTEMS, LLC

WHEREAS, the Lake County Forest Preserve District (the "District") desires to purchase door access controls, video surveillance cameras, software licensing, and related installation services (the "Equipment and Services"); and

WHEREAS, the Director of Administration and the Purchasing Manager have determined that the Equipment and Services require personal confidence; and

WHEREAS, the Information Technology Officer has solicited a proposal for the Equipment and Services from Computer Power Systems, LLC; and

WHEREAS, the District's staff, the Purchasing Manager, the Director of Administration, the Director of Education and the Director of Finance have reviewed the proposal and recommend that the Board of Commissioners (i) find that the proposal submitted by Computer Power Systems, LLC be determined to be the proposal that is most advantageous to the District; and (ii) award a contract for the Equipment and Services to Computer Power Systems, LLC (the "Contract") in the amount of \$36,915.00 (the "Contract Price"); and

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Lake County Forest Preserve District, Lake County, Illinois, **THAT**:
