BACKGROUND: These products are purchased annually to maintain the golf course grounds at all District golf courses. Bids were advertised in January, 2019. Twelve bids were received. Each yellow highlighted bid listed on the Exhibit to the attached Resolution is the lowest responsible bid for the corresponding type of product listed. Certain bids, highlighted orange, were for unacceptable alternate products and are therefore non-conforming to the bidding requirements. Certain bids, highlighted blue, were non-conforming to the bidding requirements due to use of incorrect units of measure and/or incomplete bid documents. Staff recommends that the orange and blue bids be rejected.

**A RESOLUTION AWARDING CONTRACTS FOR THE PURCHASE OF CHEMICALS
AND FERTILIZERS FOR DISTRICT GOLF COURSES**

WHEREAS, the Lake County Forest Preserve District (the “District”) has advertised in The Lake County News Sun for sealed bids to purchase chemicals and fertilizers, which are listed under the column titled “PRODUCT DESCRIPTION” on the attached exhibit (the “Products”); and

WHEREAS, all sealed bids were received and opened by the District at its General Offices, 1899 West Winchester Road, Libertyville, Illinois on January 18, 2019 at 10:00 a.m.; and such bids are summarized on the exhibit attached hereto (the “Exhibit”); and

WHEREAS, the District’s staff; the Purchasing Manager; the Director of Facilities; and the Operations Committee have reviewed the bids and based upon the bids, recommend that the Board of Commissioners (i) find that each yellow highlighted bid listed on the Exhibit, (collectively, the “Low Bids”) is a lowest responsible bid for the corresponding type of Product listed in the “PRODUCT DESCRIPTION” column of the Exhibit and (ii) award contracts for the Products to Arthur Clesen, Lincolnshire, Illinois; BTSI, New Lenox, Illinois; Chicagoland Turf, Downers Grove, Illinois; Conserv FS, Wauconda, Illinois; Great Lakes Turf, LLC, Byron Center, Michigan; SiteOne Landscape Supply, Cleveland, Ohio; Pendelton Turf Supply, Waterford, Wisconsin; Advanced Turf Solutions, Elk Grove Village, Illinois; Reinders, Inc., Elgin, Illinois; and National Seed, Lisle, Illinois, (collectively the “Bidders”) consistent therewith, pursuant to which the District may purchase such amounts of the Products that it determines are necessary or desirable for District use (the “Contracts”); and

WHEREAS, the Board of Commissioners hereby finds that each Low Bid is a lowest responsible bid for the corresponding type of Product listed in the “PRODUCT DESCRIPTION” column of the Exhibit; and

WHEREFORE, the Board of Commissioners hereby finds that the bids highlighted orange and blue on the Exhibit do not conform to the bidding specifications;

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Lake County Forest Preserve District, Lake County, Illinois THAT:

Section 1. Recitals. The recitals set forth above are incorporated as a part of this Resolution by this reference.

Section 2. Rejection of Non-Conforming Bids. The bids highlighted in orange and blue on the Exhibit are hereby rejected.

Section 3. Acceptance of Bids. The Low Bids in the amounts listed on the Exhibit (the “Contract Prices”) are hereby accepted and Contracts for the Products are hereby awarded to the Bidders.

Section 4. Award of Contract. The Executive Director of the District is hereby authorized to execute the Contracts for the Products in the amount of the Contract Prices.

Section 5. Payments. The Treasurer shall make payments under the Contract only pursuant to and in accordance with the Contract terms.

Section 6. Effective Date. This Resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.
