**RECOMMENDATION:** Recommend approval of a Resolution approving an amendment to the 2019 Legislative Program for the Lake County Forest Preserve District to seek legislation amending the Downstate Forest Preserve District Act for the purpose of providing clear authority and means for the District to remove the President for cause (note: the original staff recommendation was "because of misconduct, chronic absences, incapacity, or any other reason", but was changed to "for cause" by the Legislative Committee at its April 1, 2019, meeting).

STRATEGIC DIRECTIONS SUPPORTED: Organizational Sustainability; Leadership

**FINANCIAL DATA:** There is no financial impact.

<u>BACKGROUND:</u> In December, 2018, the District's Rules Committee requested a legal opinion on whether the District could amend its Rules of Order and Operational Procedures to include a rule allowing the Board to remove a President from office.

At the March 25, 2019, Rules Committee meeting, Corporate Counsel Matthew Norton provided an opinion to the Rules Committee that the District has no clear authority to remove the President as stated above. He advised the Rules Committee that, if they desire to adopt such a rule, the District should first seek express statutory authority to do so from the General Assembly.

The Rules Committee requested that the Legislative Committee consider an amendment to the District's 2019 Legislative Program, adding language that would authorize staff to work with the District's Legislative Consultants, Strategic Advocacy Group, LLC, to seek such an amendment to the Downstate Forest Preserve District Act.

The specific amendment to the Legislative Program would be: "Establish authority for the District to remove its President from office by super-majority vote of the Board for cause."
