RECOMMENDATION: Recommend approval of Betsy Hough to the Preservation Foundation Board of Directors for a three-year term.

FINANCIAL IMPACT: There is no immediate financial impact to the Preservation Foundation.

BACKGROUND: Under the bylaws of the Foundation, as amended on January 8, 2018, Directors of the Preservation Foundation are elected to a three-year term of service and approved by the Voting Members. The Foundation's bylaws state that the number of Directors should be between 10 and 18 members and should include two Lake County Forest Preserve District Commissioners, as appointed by the President of the Lake County Forest Preserves. The bylaws also state the Executive Director of the Forest Preserves shall be an ex-officio member of the Preservation Foundation Board of Directors with voting rights.

Under the bylaws, the Board of Directors approves a list of candidates, which may include additions to or deletions from the recommendations of the Board's Nominating Committee, if any. The Board of Directors submits its approved list of recommended candidates to the Voting Members for election at the next Annual Member Meeting.

REASON FOR RECOMMENDATION: Per the bylaws, the Board of Directors must approve nominees to the Board of Directors, whose election must then be approved by the Voting Members.
