**RECOMMENDATION:** Recommend approval of a Resolution awarding Contracts for the Purchase and Delivery of Native Seed for Grant Woods Forest Preserve and Plant Plugs for Prairie Wolf Forest Preserve to Applied Ecological Services, Brodhead, Wisconsin in the Contract Price of \$35,697.70; Cardno, Inc., Walkerton, Indiana in the Contract Price of \$27,456.58; Prairie Moon Nursery, Winona, Minnesota in the Contract Price of \$66,330.07; and Shooting Star Native Seeds, Spring Grove, Minnesota in the Contract Price of \$56,411.68.

**STRATEGIC DIRECTION SUPPORTED:** Conservation

**FINANCIAL DATA:** The purchase and delivery of native seed for Grant Woods Forest Preserve and plant plugs for Prairie Wolf was approved as part of the adopted FY 2018/2019 Natural Resource Grant Fund and Wetlands Management Fund.

The bids are tallied in Exhibit A. The bids for native seed and plugs under \$25,000.00 that do not require Committee review and Board approval total \$ 4,383.94, and, combined with the contracts that would be awarded pursuant to the attached resolution, total \$190,279.97. The seed purchases will be charged to the Grant Woods Donation account (20104100-803200-60604), in the amount of \$143,160.28. The plant plugs purchases will be charged to the Prairie Wolf Mitigation account (24614100-803200-62504), in the amount of \$47,119.69.

**BACKGROUND:** The District will be installing native seed in February of 2020 at Grant Woods Forest Preserve as part of ongoing ecological restoration efforts. Seed installation will occur in areas that have received invasive species control and additional preparations by District staff and volunteers. Seed installation will occur across 100 acres and include woodland, wetland and prairie communities.

The wetland plant plugs for Prairie Wolf Forest Preserve will be installed in the vernal pools located in the recently buckthorn-cleared 20-acre woodland south of Old Elm Road as part of the mitigation project approved by U.S. Army Corps of Engineers.

The project was advertised on October 4, 2019 and five bids were received. A summary of the lowest bids received and recommended for approval is listed below:

Materials were bid on a unit price per species.

Staff recommends that Applied Ecological Services, Cardno, Inc., Prairie Moon Nursery and Shooting Star Native Nursery each be awarded a contract as the lowest responsible bidder for the seed / plant plug species for which it was the low bidder.

Staff will award a seed/plant plug Purchase Order contract to Spence Restoration Nursery, which submitted bids totaling less than \$25,000.00.

Work is anticipated to begin in February 2020 and be completed by July 2020.

**A RESOLUTION AWARDING CONTRACTS FOR  
NATIVE SEED FOR GRANT WOODS FOREST PRESERVE AND  
PLANT PLUGS FOR PRAIRIE WOLF FOREST PRESERVE**

**WHEREAS**, the Lake County Forest Preserve District (the “District”) has advertised in The News Sun for sealed bids to purchase Native Seed for Grant Woods Forest Preserve and Plant Plugs for Prairie Wolf Forest Preserve (collectively, the “Products”) pursuant to the bidding documents for such Products (the “Bid Documents”); and

**WHEREAS**, all sealed bids were received and opened by the District at its General Offices, 1899 West Winchester Road, Libertyville, Illinois, on October 23, 2019, at 10:00 a.m.; and

**WHEREAS**, the District’s staff, the Purchasing Manager, the Director of Natural Resources; and the Planning Committee have reviewed the bids identified on Exhibit A and recommend that the Board of Commissioners find (i) Applied Ecological Services, Inc. to be the lowest responsible bidder with respect to the yellow highlighted bids listed under “Applied Ecological Services” on Exhibit A (the “Applied Ecological Services, Inc. Bids”), (ii) Cardno, Inc. to be the lowest responsible bidder with respect to the yellow highlighted bids listed under “Cardno, Inc.” on Exhibit A (“the Cardno, Inc. Bids”), (iii) Prairie Moon Nursery to be the lowest responsible bidder with respect to the yellow highlighted bids listed under “Prairie Moon Nursery” on Exhibit A (“the Prairie Moon Nursery Bids”), and (iv) Shooting Star Native Seeds to be the lowest responsible bidder with respect to the yellow highlighted bids listed under “Shooting Star Native Seeds” on Exhibit A (“the Shooting Star Native Seeds Bids”) and award contracts for the Products to these bidders consistent therewith; and

**WHEREAS**, the Board of Commissioners hereby finds that Applied Ecological Services, Inc., Cardno, Inc., Prairie Moon Nursery, and Shooting Star Native Seeds are the lowest responsible bidders for the Products, as set forth in the previous clause;

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners of the Lake County Forest Preserve District, Lake County, Illinois, **THAT**:

**Section 1: Recitals.** The recitals set forth above are incorporated as a part of this Resolution by this reference.

**Section 2: Award of Contract.** The Applied Ecological Services, Inc. Bids in the total amount of \$35,697.70 (the “Applied Ecological Services, Inc. Contract Price”) are hereby accepted and a contract for Products in the amount of the Applied Ecological Services, Inc. Contract Price is hereby awarded to Applied Ecological Services, Inc. (the “Applied Ecological Services, Inc. Contract”). The Cardno, Inc. Bids in the total amount of \$27,456.58 (the “Cardno, Inc. Contract Price”) are hereby accepted and a contract for Products in the amount of the Cardno, Inc. Contract Price is hereby awarded to Cardno, Inc. (the “Cardno, Inc. Contract”). The Prairie Moon Nursery Bids in the total amount of \$66,330.07 (the “Prairie Moon Nursery Contract Price”) are hereby accepted and a contract for Products in the amount of the Prairie Moon Nursery Contract Price is hereby awarded to Prairie Moon Nursery (the “Prairie Moon Nursery Contract”). The Shooting Star Native Seeds Bids in the total amount of \$56,411.68 (the “Shooting Star Native Seeds Contract Price”) are hereby accepted and a contract for

the Products in the amount of the Shooting Star Native Seeds Contract Price is hereby awarded to Shooting Star Native Seeds (the “Shooting Star Native Seeds Contract”), (collectively, the Applied Ecological Services, Inc. Contract, the Cardno, Inc. Contract, the Prairie Moon Nursery Contract, and the Shooting Star Native Seeds are the “Contracts”; collectively, the Applied Ecological Services, Inc. Contract Price, the Cardno, Inc. Contract Price, the Prairie Moon Nursery Contract Price, and the Shooting Star Native Seeds Contract Price are the “Contract Prices” ).

**Section 3: Execution of Contracts.** The Executive Director of the District is hereby authorized and directed to execute the Contracts for the Products in the amounts of their respective Contract Prices.

**Section 4: Payments.** The District Treasurer shall make payments under the Contracts only pursuant to and in accordance with the Contracts’ terms.

**Section 5: Effective Date.** This Resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.
