**RECOMMENDATION:** Recommend approval of a Resolution Awarding one-year Contracts with options for two one-year extensions, for Public Safety Department uniforms and equipment to each of the following vendors: (i) Ray O’Herron Company, Inc., Danville, Illinois, and (ii) Galls, LLC, Lexington, Kentucky, in amounts not to exceed \$33,000.00 in total, for both contracts, in year one and not to exceed funds budgeted and appropriated for uniform and equipment expenditures during the extensions.

**STRATEGIC DIRECTION SUPPORTED:** Organizational Sustainability

**FINANCIAL DATA:** The Public Safety Department budget for uniforms and equipment in the approved 2020 General Corporate Budget \$33,000.00 (13563800-612000).

**BACKGROUND:** The Lake County Forest Preserve District (the “District”) maintains a Public Safety Department with uniformed police officers and purchases new and replacement uniforms and equipment for the Department members. The District solicited bids for various components and types of uniforms and equipment. The District received bids from two bidders, Ray O’Herron Company, Inc. and Galls, LLC. Each bidder is the low bidder on a number of different uniform components and equipment types. Staff recommends that the District award a contract to each bidder for the uniform and equipment items for which it was the low bidder. Each contract would have a one-year term, with two one-year extensions that the District could exercise at its discretion.

**A RESOLUTION AWARDING CONTRACTS FOR  
UNIFORMS AND EQUIPMENT FOR RANGER POLICE OFFICERS  
TO RAY O’HERRON COMPANY, INC. AND GALLS, LLC**

**WHEREAS**, the Lake County Forest Preserve District (the “District”) has advertised in The News Sun for sealed bids for the purchase of uniforms and equipment for District Ranger Police Officers (the “Products”) pursuant to a contract with an initial term of one year (the “Initial Term”) and two one-year extensions that may be exercised at the discretion of the District (the “Future Extensions”); and

**WHEREAS**, all sealed bids were received and opened by the District at its General Offices, 1899 West Winchester Road, Libertyville, Illinois, on December 4, 2019, at 10:00 a.m.; and

**WHEREAS**, the District’s staff, the Purchasing Manager, the Director of Public Safety, and the Operations and Finance Committees have reviewed the bids and recommend that the Board of Commissioners (i) find Ray O’Herron Company, Inc., to be the lowest responsible bidder with respect to the bids that it submitted and which are listed under the column titled “Ray O’ Herron Company, Inc.” on Exhibit A (the “Ray O’Herron Company, Inc. Bids”), (ii) find Galls, LLC, to be the lowest responsible bidder with respect to the bids that it submitted and which are listed under the column titled “Galls, LLC” on Exhibit A (the “Galls, LLC Bids”), and (iii) award contracts for the Products to these bidders consistent therewith; and

**WHEREAS**, the Board of Commissioners hereby finds that Ray O’Herron Company, Inc., and Galls, LLC are the lowest responsible bidders for the Products, as stated in the previous clause;

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners of the Lake County Forest Preserve District, Lake County, Illinois, **THAT**:

**Section 1: Recitals.** The recitals set forth above are incorporated as a part of this Resolution by this reference.

**Section 2: Award of Contracts.** The Ray O’Herron Company, Inc. Bids are hereby accepted and a contract for the Products corresponding to the Ray O’Herron Company, Inc. Bids are hereby awarded to Ray O’Herron Company, Inc. (the “Ray O’Herron Company, Inc. Contract”). The Galls, LLC Bids are hereby accepted and a contract for the Products corresponding to the Galls, LLC Bids are hereby awarded to Galls, LLC (the “Galls, LLC Contract”; the Ray O’Herron Company, Inc. Contract and the Galls, LLC Contract are, collectively, the “Contracts”).

**Section 3: Execution of Contracts; Future Extensions.** The Executive Director of the District is hereby authorized and directed to execute the Contracts. The Executive Director is hereby authorized to approve the Future Extensions on behalf of the District.

**Section 4: Payments.** The Treasurer shall make payments under the Contracts only pursuant to and in accordance with the Contracts' terms; however, (i) during the Initial Term, the amount paid by the District for the Ray O'Herron Company, Inc. Contract plus the amount paid by the District for the Galls, LLC Contract shall not exceed \$33,000.00 and (ii) during a Future Extension, the amount paid by the District shall not exceed the amounts budgeted and appropriated for the Products during such Future Extension.

**Section 5: Effective Date.** This Resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.
