SUBJECT: Restrictive Covenant for Pine Dunes - Tollway Mitigation Project

RECOMMENDATION: Recommend approval of a Resolution approving a Restrictive Covenant for the Pine Dunes - Tollway Mitigation Site

BACKGROUND: As part of the U. S. Army Corps of Engineers (ACOE) Wetland Permit for the Illinois State Toll Highway Authority's (ISTHA) Elgin O' Hare West Bypass Project, ISTHA was required to provide mitigation for the wetland impacts caused by the construction of the project. The District entered into an Intergovernmental Agreement with ISTHA in May 2013 allowing ISTHA to implement the mitigation by creating and enhancing wetland areas on a portion of the Pine Dunes Forest Preserve (formerly known as the Sexton parcel) and providing for the installation of trails, bridges, and other improvements, all in accordance with plans approved by the District. As part of the ACOE permit, a Restrictive Covenant must be recorded against Pine Dunes to ensure that the new and enhanced wetland areas are protected and limited to those uses.

REASON FOR RECOMMENDATION: Committee recommendation and Board approval are required in accordance with District policy.

A RESOLUTION APPROVING A DECLARATION OF RESTRICTIVE COVENANTS FOR THE PINE DUNES FOREST PRESERVE - TOLLWAY MITIGATION SITE

WHEREAS, the Lake County Forest Preserve District (the "District") is the owner of 797.3 acres of land, commonly known as Pine Dunes Forest Preserve; and

WHEREAS, Pine Dunes Forest Preserve is located in Newport Township, Lake County, Illinois; and

WHEREAS, the District desires to place a restrictive covenant over approximately 318 acres of Pine Dunes Forest Preserve (the "Subject Property"); and

WHEREAS, the District has the authority to grant restrictive covenants as conservation rights pursuant to the authority provided in the Real Property Conservation Rights Act, 765 ILCS 120/0.01 et seq.; and

WHEREAS, it is in the best interests of the District to place a restrictive covenants on the Subject Property by approving and executing a declaration of conservation rights and/or restrictive covenants;

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Lake County Forest Preserve District, Lake County, Illinois THAT:

<u>Section 1</u>. <u>Recitals</u>. The recitals set forth above are incorporated as part of this Resolution by this reference.

<u>Section 2</u>. <u>Ownership and Boundaries</u>. The Property is fully owned by the District and is depicted on the attached Exhibit A, and lies wholly within the limits of the District.

<u>Section 3.</u> <u>Approval of Declaration.</u> The Executive Director of the District is hereby authorized to execute and record against the Subject Property a declaration of conservation rights and/or restrictive covenants, in substantially the form attached hereto or in such other form as is approved by the District's General Counsel (the "Declaration").

<u>Section 4</u>. <u>Effective Date</u>. This Resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.
