**<u>RECOMMENDATION</u>**: Approve the award of five farm licenses at Ray Lake, Dutch Gap, Kestrel Ridge and Pine Dunes Forest Preserves to the highest qualified bidders.

STRATEGIC DIRECTIONS SUPPORTED: Conservation; Organizational Sustainability

**<u>FINANCIAL DATA</u>**: Awarding the licenses will generate \$109,166.02 annually and will be credited to the Farmland Management Fund (28642500-403000). Revenue generated from this land in 2020 was \$114,749.44.

**BACKGROUND:** The farming program is conducted with farmers to provide cost-effective, interim land use and management until the District is ready to convert farmland to other forest preserve purposes. The current license agreement for the Ray Lake parcel expires on October 26, 2020; all other agreements expire on December 31, 2020. The farm licenses were advertised in the News-Sun and bid packages were available on the District's website. The Ray Lake license was advertised for a 3-year term and all other parcels were advertised for a 4-year term, with all terms starting January 1, 2021. Four potential licensees submitted bids. The highest qualified bidders for the parcels are noted below:
