<u>RECOMMENDATION</u>: Recommend Approval of a Resolution Nominating the 2021 Board of Directors of the Preservation Foundation.

FINANCIAL DATA: No Financial Impact.

BACKGROUND: Under the bylaws of the Foundation, as amended on January 8, 2018, Directors of the Preservation Foundation are elected to a three-year term of service and approved annually by the Voting Members at the Annual Member Meeting. The Foundation's bylaws state the number of Directors should be between 10 and 18 members and should include two Lake County Forest Preserve District Commissioners, as appointed by the President of the Forest Preserves. The bylaws also state the Forest Preserve Executive Director shall be an ex-officio member of the Preservation Foundation Board of Directors with voting rights.

The Board of Directors approves a list of candidates, which may include additions to or deletions from the recommendations of the Board's Executive Committee, if any. The Board of Directors submits its approved list of recommended candidates to the Voting Members for election at the next Annual Member Meeting.

WHEREAS, the bylaws also state that the Board of Directors shall include two Lake County Forest Preserve District Commissioners, as appointed by the President of the Forest Preserves; and

WHEREAS, whereas Lake County Forest Preserves President Angelo Kyle has selected Commissioner S. Michael Rummel and Commissioner Paul Frank to serve on the Board of Directors; and

WHEREAS, the bylaws state that Lake County Forest Preserves Executive Director Alex Ty Kovach shall be an ex-officio member of the Preservation Foundation Board of Directors with voting rights; and

WHEREAS, the 8 other candidates for the Board of Directors were nominated by the Preservation Foundation Executive Committee;

NOW, THEREFORE, BE IT ORDAINED, by the Preservation Foundation Board of the Lake County Forest Preserve District, Lake County, Illinois that:

<u>Section 1</u>: <u>Recitals</u>. The recitals set forth above are incorporated as part of this Ordinance by this reference.

Section 2: Election of the Board of Directors. The Voting Members hereby elect 11 members of the board of directors: Nels R. Leutwiler; Andrea S. Moore; S. Michael Rummel; Andrea L. Danks; Walter W. Dalitsch; Paul Frank; Karen M. Hunter; Alex Ty Kovach; Elizabeth Hough; Mary Vincent; and Renee Young.
