REQUEST: Updated policy direction requested with respect to the classification of District buildings.

STRATEGIC DIRECTION SUPPORTED: Organizational Sustainability

FINANCIAL DATA: There are no financial impacts at this time.

BACKGROUND:

Previous Committee Direction

During the June 2015, September 2015, and December 2015 committee cycles, the District's standing committees considered and issued policy direction regarding the status of the District's buildings. Pursuant to that direction, the District's inventory of 156 buildings at that time, totaling approximately 705,983 square feet, were classified as follows:

- "Forever" 40 buildings (259,916 sf). The District is committed to keeping these buildings for the long term. Funds will be budgeted and included in the District's Capital Improvement Plan for replacements, repairs and upgrades accordingly.
- Maintain 37 buildings (99,738 sf). These buildings are currently in use and serve a District purpose. Continued basic funding for maintenance will be budgeted.
- To Be Evaluated 8 buildings (15,389 sf). These buildings are currently in use, but their long-term status depends upon whether future needs for the buildings will exist.
- In Use To Be Removed 42 buildings (196,839 sf). These buildings are currently being used, but will be removed when the current function ceases or if significant repairs are needed.
- Awaiting Removal 29 buildings (134,101 sf). These buildings are vacant and unused, and will be salvaged, recycled and removed as soon as practical.

For information, the term "building" is generally defined as a structure that has four walls and includes electric, plumbing and/or HVAC systems, or structures that provide support to other "buildings" (e.g. material storage bins or sheds). The list of "buildings" does not include numerous other structures that the District owns and maintains, including but not limited to picnic shelters, comfort stations, and kiosks. Also, for information, the area of a building is the planimetric size of the building (i.e. the building footprint as observed from above), not the

useable floor space of the building (e.g. the General Offices is noted as 31,635 square feet, but has three stories and a basement for over 100,000 sf of floor space).

Building Inventory Update

Since the end of 2015, the inventory of District buildings has changed as follows:

- Added nineteen (19) buildings totaling 17,067 sf through acquisitions of land upon which existing buildings are located, including:
 - Lakewood Stuckmann (2), Ray Lake Cuneo (2), Ray Lake White (6), and Ray Lake Dearlove (9).
- Removed thirty-seven (37) buildings totaling 166,438 sf.
- Identified one (1) non-District building (i.e., a building on District property operated and maintained by another governmental agency under an intergovernmental agreement) measuring 10,730 sf that was not included in the previous discussions.

Therefore, there are currently 139 buildings totaling 573,219 sf.

Recommended Updates to Building Classifications

Since the Committees last provided direction in 2015, the District has made a few significant decisions regarding the disposition of District buildings that supersede the original policy direction and need to be tracked. Also, based on other changes in building use and/or building conditions since 2015, other updates to the overall policy direction are warranted. Following is a list of recommended updates to the overall policy direction.

- 1. The following buildings are no longer in use, and are re-categorized to "Awaiting Removal"
 - a. Prairie Stream Bath Storage Building
 - b. Ray Lake Diebold farm buildings (5)
- 2. Based on the current license with the Brushwood Center at Ryerson Woods, the three Brushwood buildings at Ryerson are re-categorized from "To Be Evaluated" to "Maintain"
- 3. As part of the Lakewood Master Plan discussion and approval process, the following classifications were essentially established for the five buildings at Lakewood that were "To Be Evaluated" and one other.
 - a. Shelter E Bathroom "Forever"
 - b. Bat Pavilion "Maintain"
 - c. Barn/Silos "Maintain"
 - d. Valve Houses (2) "In Use To Be Removed"
 - e. Duplex (Temporary Housing) "In Use To Be Removed"
- 4. Based on current and planned investments in facilities supporting grounds maintenance operations, the following updates are suggested:
 - a. Heron Creek Garage "In Use To Be Removed"
 - b. Old School Maintenance Shop and Material Storage Bins "Forever"

- 5. The District recently acquired the Dearlove property at Ray Lake, which includes nine (9) buildings. Six of those buildings are vacant and should be identified as "Awaiting Removal". Three of the buildings are licensed for use through 2025, and should be identified as "In Use To Be Removed".
- 6. A "Non-District Building" category is created for the following three buildings:
 - a. Almond Marsh Lake County Public Works Building
 - b. Atkinson Stormwater Facility Pumphouse
 - c. Duffy Stormwater Facility Pumphouse

Assuming concurrence with the above recommendations, the District's current inventory of 139 buildings will be classified as follows:

- "Forever" 43 buildings (263,153 sf). The District is committed to keeping these structures for the long term. Funds will be budgeted and included in the CIP for replacements, repairs and upgrades accordingly.
- Maintain 36 buildings (106,826 sf). These structures are currently in use and serve a District purpose. Continued basic funding for maintenance will be budgeted.
- In Use To Be Removed 34 buildings (135,087 sf). These structures are currently being used, but will be removed when the current function ceases or if significant repairs are needed.
- Awaiting Removal 23 buildings (56,803 sf). These structures are vacant and unused, and will be salvaged, recycled and removed as soon as practical.
- Non-District Buildings 3 buildings (11,350 sf). This new category is for buildings on District property operated and maintained by other governmental agencies in accordance with existing intergovernmental agreements.
