RECOMMENDATION: Resolution Recommending approval Bob Shears to a three-year term as a member of the Preservation Foundation Board of Directors

FINANCIAL DATA: There is no financial impact at this time.

BACKGROUND: Under the bylaws of the Foundation, as amended on January 8, 2018, Directors of the Preservation Foundation are elected to a three-year term of service and approved by the Voting Members. The Foundation's bylaws state that the number of Directors should be between 10 and 18 members and should include two Lake County Forest Preserve District Commissioners, as appointed by the President of the Lake County Forest Preserves. The bylaws also state the Executive Director of the Forest Preserves shall be an ex-oficio member of the Preservation Foundation Board of Directors with voting rights.

Under the bylaws, the Board of Directors approves a list of candidates, which may include additions to or deletions from the recommendations of the Board's Nominating Committee, if any. The Board of Directors submits its approved list of recommended candidates to the Voting Members for election at the next Annual Member Meeting.

The Preservation Foundation Executive Committee convened on May 5, 2021 and nominated Bob Shears of Mundelein, Illinois to serve a three-year term on the Preservation Foundation Board of Directors. Mr. Shears is former executive director of YCC, Inc., which has had a decades-long partnership with the Forest Preserves. He has been a restoration volunteer for several years and is currently in training to become a volunteer site steward. He has been a donor to the Preservation Foundation since April 2021.
