**<u>RECOMMENDATION</u>**: Recommend approval of a Resolution awarding contracts for the purchase of gravel and other materials for a thirty (30) month period beginning July 1, 2021 and ending December 31, 2023, to Potsie's Inc.; Super Aggregates, Inc.; Thelen Materials, LLC; and Waupaca Sand & Solutions.

## **STRATEGIC DIRECTION SUPPORTED:** Organizational Sustainability

**<u>FINANCIAL DATA</u>**: Gravel, sand and other materials are ordered on an as-needed basis depending upon the project and delivery location. The actual costs are charged to the appropriate operating account based upon the material and department using the material.

**BACKGROUND:** The District solicited bids for gravel, sand and other materials used for maintenance, repair and improvement projects throughout the District. The District solicited bids for gravel and material (i) to be delivered to sites within three different areas within the District and (ii) to be picked up at the pit. A total of six bidders submitted bids as listed on the Exhibit to the Resolution. One bidder, Utility Transport Service, Inc. has requested to withdraw its bids because it mistakenly omitted cartage expenses from their bids, which are highlighted in red on the Exhibit to the Resolution. Staff is recommending that Utility Transport Service, Inc., be allowed to withdraw its bid and is recommending award of contracts to the other low bidders that submitted the bids highlighted in yellow on the Exhibit to the Resolution.

### A RESOLUTION AWARDING CONTRACTS FOR THE PURCHASE OF GRAVEL AND MATERIALS

**WHEREAS**, the Lake County Forest Preserve District (the "District") has advertised in <u>The</u> <u>Lake County News Sun</u> for sealed bids to purchase Gravel and Materials (the "Materials"); and

**WHEREAS,** all sealed bids were received and opened by the District at its General Offices, 1899 West Winchester Road, Libertyville, Illinois on April 7, 2021 at 11:00 a.m.; and

**WHEREAS,** Utility Transport Service, Inc. has requested that they be allowed to withdraw their bid as highlighted red on the Exhibit, stating that prices did not include cartage (the "Incorrect Bids"); and

**WHEREAS,** the District's staff, the Purchasing Manager, the Operations Committee, and the Finance Committee have reviewed the bids and have prepared the attached exhibit (the "Exhibit"), which identifies, in each line item (i) each type of Material the District desires to purchase, (ii) the delivery area for such Material, (iii) a bidder who has offered to deliver such Material to such area, and (iv) the bidder's proposed price for such Material with the low bids, which (excluding the Incorrect Bids) are highlighted in yellow; and

WHEREAS, the District's staff, the Purchasing Manager, the Operations Committee, and the Finance Committee recommend that the Board of Commissioners (i) allow the Incorrect Bids to be withdrawn (ii) find that each yellow-highlighted bid listed on the Exhibit (collectively, the "Low Bids") is the lowest responsible bid for the type of Material and the delivery area corresponding to such Low Bid and (iii) award a contract to each bidder who submitted a Low Bid (collectively, the "Low Bidders") in an amount equal to the Low Bids (the "Contract Prices") submitted by such Low Bidder (collectively, the "Contracts"); and

**WHEREAS**, the Board of Commissioners hereby finds that the Low Bidders are the lowest responsible bidders for the Materials, as set forth in the previous recital;

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners of the Lake County Forest Preserve District, Lake County, Illinois, **THAT**:

<u>Section 1:</u> <u>Recitals.</u> The recitals set forth above are incorporated as part of this Resolution by this reference.

Section 2: <u>Withdrawal of Incorrect Bids.</u> The Incorrect Bids are hereby allowed to be withdrawn and are rejected.

**Section 3:** <u>Award of Contract.</u> The Low Bids submitted by the Low Bidders are hereby accepted and a Contract for Materials is hereby awarded to each Low Bidder, for the Materials for which it submitted a Low Bid, in the amount of the Contract Prices corresponding to such Low Bids.

<u>Section 4:</u> <u>Execution of Contract.</u> The Executive Director of the District is hereby authorized and directed to execute the Contracts with the Low Bidders for the Materials in the amounts of the Contract Prices.

<u>Section 5:</u> <u>Payments.</u> The District Treasurer shall make payments under the Contracts only pursuant to and in accordance with the Contracts' terms.

Section 6: Effective Date. This Resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.
