**RECOMMENDATION:** Recommend approval of a Resolution awarding a Contract for the Woody Invasive Plant Clearing – Winter 2021 Project at Prairie Wolf Forest Preserve to Clean Cut Tree Service in the Contract Price of \$115,200.00.

**STRATEGIC DIRECTION SUPPORTED:** Conservation

**FINANCIAL DATA:** The estimated cost for the project was \$160,000.00. The actual cost of the project under the contract that would be approved by the attached resolution is \$115,200.00.

The Woody Invasive Plant Clearing for Prairie Wolf Forest Preserve will begin in the winter of 2021 and will be completed in the fall of 2022. Funding comes from the FY 2021 Wetland Restoration Fund (24614100-803200-62506) in the amount of \$115,200.00.

**BACKGROUND:** Invasive plants are a significant challenge to habitat restoration. Management of invasive plants is necessary to improve and restore habitat quality and species diversity on District properties throughout Lake County. The District conducts removal of invasive woody species as part of a Land Management Program to restore and enhance woodlands, savannas, prairies and wetlands to increase the health, diversity, and sustainability of flora and wildlife populations and to restore or enhance ecosystem services.

In 2020, the District was awarded a grant in the amount of \$177,260.00 from the National Fish and Wildlife Foundation’s Chi-Cal Rivers Fund Grant. This grant funds restoration work within the Chicago and Calumet River Watersheds in the Chicago region. This grant will allow the District to restore the northern portion of Prairie Wolf Forest Preserve. In addition to clearing work, this project also includes wetland restoration, streambank stabilization, and invasive herbaceous species management.

The project was advertised on June 24, 2021 and seven bids were received. A summary of the bids received is listed below:

Staff recommends that Clean Cut Tree Service be awarded the contract as the lowest responsible bidder. Work is anticipated to begin December 13, 2021 and to be completed by August 1, 2022.

**Section 3: Execution of Contract.** The Executive Director of the District is hereby authorized and directed to execute the Contract for the Work in the amount of the Contract Price.

**Section 4: Payments.** The Treasurer shall make payments under the Contract only pursuant to and in accordance with the Contract terms.

**Section 5: Effective Date.** This Resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.
