RECOMMENDATION: Recommend approval of a Resolution awarding a Contract for the Schaeffer Road Trail Crossing Accessibility Improvements at Buffalo Creek Forest Preserve to Chicagoland Paving Contractors, Inc., in the Contract Price of \$35,000.00.

STRATEGIC DIRECTION SUPPORTED: Public Access and Connections.

FINANCIAL DATA: The cost of this work will be charged to account 11104100-803200-60030 District-wide Accessibility Improvements. This project was included as part of the adopted FY 2021 Capital Improvement Plan in the amount of \$170,072.00 for accessibility improvements.

BACKGROUND: Under Title II of the Americans with Disabilities Act (ADA), the Lake County Forest Preserve District must make its services, programs, and activities readily accessible to individuals with disabilities. The District is committed to enhancing accessibility over and above ADA requirements. In furtherance of that goal, it has allocated \$100,000.00 annually in the 10-year Capital Improvement Plan to address accessibility needs. In 2019, the District produced a supplemental Transition Plan to bring its facilities in compliance with federal and state accessibility standards. The largest estimated costs are related to parking and trail issues.

Within Buffalo Creek Forest Preserve, a primary trail connects the east and west halves of the preserve with a crossing over Schaeffer Road. Recently, a visitor, whose son uses a manual mobility device, notified the District that the existing crossing was very difficult and potentially unsafe due to the steepness of the asphalt ramp leading from the trail up to the roadway and the common occurrence of passing vehicles exceeding the posted speed limit. District staff assessed the crossing and concluded that the trail slopes exceed accessibility standards.

At its August 2 meeting, the Planning Committee gave staff direction to District staff to pursue an intergovernmental agreement with Vernon Township, under which the Township would fund the installation and long term maintenance of rectangular rapid flashing beacons adjacent to the crosswalk. At its August 12th meeting, the Township Board declined to fund any portion of this project. Staff recommends that the District move forward with the accessibility improvement portion of the project which includes re-grading the existing trail profile to improve access across Schaeffer Road, installation of accessible concrete ramps with detectable warning plates and restriping the crosswalk.

The project was advertised on June 1, 2021 and six bids were received. A summary of the bids received is listed below:

Staff recommends that Chicagoland Paving Contractors, Inc. be awarded the contract as the lowest responsible bidder. Work is anticipated to begin September 27, 2021 and be completed by October 29, 2021.
