RECOMMENDATION: Approve Change Order No. 1 to the Contract with Waste Management of Illinois, Inc. for District-Wide Refuse and Recycling Services in an amount not-to-exceed \$70,729.20.

STRATEGIC DIRECTIONS SUPPORTED: Organizational Sustainability; Public Access & Connections

<u>FINANCIAL DATA:</u> Funding for the refuse and recycling collection comes from the adopted budget line items for disposal in multiple accounts including:

\$50,000.00 for General District 15524000-704400; \$1,900.00 for Countryside 80864000-704400; \$600.00 for Brae Loch 81864000-704400 \$1,800.00 for ThunderHawk 83864000-704400

BACKGROUND: In 2016, the District entered into a contract (the "2016 Contract") with Advanced Disposal Services Solid Waste Midwest, LLC ("Advanced Disposal") for district-wide refuse and recycling services. On October 30, 2020, Advanced Disposal was acquired by Waste Management of Illinois, Inc. ("Waste Management"). Waste Management has continued to service the 2016 Contract, which was set to expire on September 30, 2021, and was extended in accordance with the terms of the 2016 Contract through December 31, 2021.

On two separate occasions, the District has recently solicited competitive bids for a new contract for Refuse Disposal and Recycling Collection. The first time was in June 2021. Sealed bids were received and opened on July 8, 2021, and are summarized as follows:

Waste Management of Illinois Inc., Waukegan, Illinois \$67,471.20 Prairieland Disposal, Inc., Barrington, Illinois \$82,165.40 At that time, it was determined that Waste Management's bid was non-responsive, because it proposed many deviations from the bid specifications and contract language, and both bids exceeded the budget amount. Therefore, the project specifications were updated, and the District again advertised for bids on August 24, 2021. Two (2) bids were received and opened on September 9, 2021, and are summarized as follows:

Both bids were again over-budget, and again Waste Management's bid proposed many deviations from the bid specifications and contract language and therefore was deemed non-responsive.

Following consultation with the District's Corporate Counsel, it was determined that the District could negotiate a change order to extend the term, and amend provisions, of the 2016 Contract. As such, staff has negotiated Change Order Number 1 to the Contract with Waste Management that will extend service through December 31, 2022 and recommends its approval.

Change Order No. 1 to Contract between Lake County Forest Preserve District and Waste Management of Illinois, Inc. for Refuse and Recycling Services

This Change Order No. 1 ("Change Order No. 1") to the certain Contract for Refuse and Recycling Services ("Contract") is dated as of December 14, 2021 and is between the Lake County Forest Preserve District ("Owner") and Waste Management of Illinois, Inc., a Delaware Corporation ("Waste Management" or "Bidder"). In consideration of the mutual covenants set forth in the Change Order No. 1, the receipt and sufficiency of which are hereby acknowledged, Owner and Waste Management agree as follows:

Section 1. Recitals.

- **A.** On September 13, 2016, Owner and Advanced Disposal Services Solid Waste Midwest, LLC ("Advanced Disposal") entered into the Contract for Refuse and Recycling Services.
- **B.** Advanced Disposal was acquired by Waste Management on October 30, 2020 and the Contract has been assumed by Waste Management.
- **C.** Owner and Waste Management desire to amend the Contract to provide that Bidder shall continue to provide the Products to the District until December 31, 2022, for a total Contract price not to exceed \$70,279.20, for Products provided to the District from January 1, 2022 through December 31, 2022.

Section 2. Definitions; Rules of Construction.

- A. <u>Definitions.</u> All capitalized words and phrases used in this Change Order No. 1 have the meanings set forth (i) in this Change Order No. 1 or (ii) if not specifically defined in this Change Order No. 1, the Contract.
- **B.** <u>Rules of Construction.</u> Except as specifically provided in this Change Order No. 1, all terms, provisions and requirements contained in the Contract remain unchanged and in full force and effect. In the event of a conflict between the Contract and Change Order No. 1, Change Order No. 1 controls.

Section 3. Amendments.

A. <u>Schedule of Prices.</u> Immediately prior to Section 2.B of the Contract, the following new language is added:

"Bidder proposes and agrees that Bidder shall deliver the Products in accordance with the following Schedule of Prices, which will apply to Products delivered between January 1, 2022 and December 31, 2022:
