RECOMMENDATION: Recommend approval of a Resolution approving Change Order No. 2 to the Contract with Perspectives, LTD. for Leadership Coaching Services and Assessment, increasing the contract amount by \$1,950.00.

STRATEGIC DIRECTION SUPPORTED: Organizational Sustainability

FINANCIAL DATA: Consulting services are included as part of the budget.

BACKGROUND: In June, the District engaged Perspectives for leadership coaching and assessment services for the members of the Public Safety Command Staff. This engagement included individual coaching and assessments and Department group coaching.

After the first phase, Command staff was surveyed about their engagement and interest in continuing with the program. The group expressed unanimous opinion that the sessions were valuable and there was interest in continuing; therefore, a second phase was entered into (change order #1). To complete the process and receive a final assessment of the program, the District would need to approve change order #2 authorizing the expenditure of additional hours by Perspectives.

WHEREAS, as of June 21, 2021, the Lake County Forest Preserve District (the "District") and Perspectives LTD (the "Consultant") entered into a contract (the "Contract") for Leadership Coaching Services and Assessment (the "Services"); and

WHEREAS, the District desires to increase the final Contract price by \$1,950.00 for additional Services to the District (the "Additional Services"), all as provided in Change Order No. 2 attached hereto ("Change Order No. 2");

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Lake County Forest Preserve District, Lake County, Illinois, THAT:

<u>Section 3.</u> <u>Placement in Contract File.</u> This resolution and Change Order No. 2 shall be preserved in the permanent District file of the Contract. This Resolution shall constitute the written determination required by Section 33E-9 of the Illinois Criminal Code, 720 ILCS 5/33E-9.

<u>Section 4.</u> <u>Effective Date.</u> This Resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.
