RECOMMENDATION: Recommend Approval of a Resolution Awarding a Contract to Altorfer Industries, Inc. for the purchase of one Asphalt Paver in the amount of \$174,380.80.

STRATEGIC DIRECTIONS SUPPORTED: Organizational Sustainability; Public Access and Connections

FINANCIAL DATA: The new Asphalt Paver will replace equipment Unit 245. This replacement was approved as part of the adopted Equipment Replacement Fund budget (92104100-804000) in the amount of \$116,000.00. The total actual cost of the equipment to be purchased will be \$174,380.80. The significant discrepancy is due primarily to three factors: the piece being replaced will have been held and used for six years beyond its planned life expectancy and prices have escalated during that time period (~23%); increases due to more stringent emissions requirements (~3%); and price increases in the past two years due to supply chain issues and sharp hikes in the price of steel and fuel used to manufacture the equipment (~18%). Recent auction results have yielded higher than expected sale prices for replaced equipment, so there is the potential that more revenue than expected will accrue to the Equipment Replacement Fund. Any additional amount of funding needed will come from the Equipment Replacement Fund and the annual user charge will be recalculated based on the actual total purchase price.

BACKGROUND: In accordance with the District's equipment replacement guidelines, staff determined previously that equipment Unit 245, a 2002 Gilcrest ProPave Model 813 Paver, is due for replacement. Staff investigated options for new pavers, demonstrated and priced two brands of paver equipment, and is recommending that a new 2022 Weiler P265 be purchased. The desired replacement piece would be purchased through a Sourcewell contract, pursuant to the Illinois Governmental Joint Purchasing Act. Sourcewell (formerly known as The National Joint Powers Alliance) is an intergovernmental purchasing cooperative and unit of local government created by the Minnesota legislature (Minn. Const. art. XII, sec. 3).

The new paver is expected to be in service for fifteen (15) years per the District's equipment replacement guidelines.

A RESOLUTION AWARDING A CONTRACT TO ALTORFER INDUSTRIES, INC. FOR THE PURCHASE OF ONE ASPHALT PAVER

WHEREAS, the Lake County Forest Preserve District (the "District") desires to purchase one Weiler Model P265 asphalt paver or approved equivalent (the "Equipment"); and

WHEREAS, pursuant to the Illinois Governmental Joint Purchasing Act, 30 ILCS 525/1, et seq., any governmental unit may purchase personal property, supplies, and services jointly with one or more other governmental units if one of the governmental units has publicly advertised for, and received, competitive, sealed bids or proposals, and has awarded a contract for such personal property, supplies, and services to the lowest responsible bidder or the highest ranking proposer, all in accordance with such Act; and

WHEREAS, Sourcewell has publicly advertised for, and received, competitive proposals for the Equipment, including a proposal by Weiler for the Equipment; and

WHEREAS, Sourcewell has awarded contract #052417-WLR to Weiler as the highest-ranking proposer for the Equipment (the "Sourcewell Contract") and the Sourcewell Contract provides that other units of local government may also enter into contracts with Weiler on the same terms as provided in the Sourcewell Contract; and

WHEREAS, it is in the best interest of the District to award a contract for the Equipment to Altorfer Industries, Inc., as the agent of Weiler, on the same terms as provided in the Sourcewell Contract (the "Contract") in a total price equal to \$174,380.80 (the "Contract Price");

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Lake County Forest Preserve District, Lake County, Illinois, THAT:

<u>Section 1</u>. <u>Recitals</u>. The recitals set forth above are incorporated as a part of this Resolution by this reference.

<u>Section 2.</u> <u>Award of Contract.</u> The proposal submitted by Weiler, in the total amount of the Contract Price is hereby accepted and the Contract is hereby awarded to Altorfer Industries, Inc., as the agent of Weiler. In the alternative, the Executive Director is authorized to award the Contract to any authorized agent of Weiler.

Section 3. Execution of Contract. The Executive Director of the District is hereby authorized and directed to execute the Contract with Altorfer Industries, Inc., in the amount of the Contract Price.

<u>Section 4.</u> <u>Payments.</u> The District Treasurer shall make payments under the Contract only pursuant to and in accordance with the Contract terms.






