RECOMMENDATION: Recommend approval of a Resolution awarding a contract for the purchase and installation of a Turn-Key Wireless (Wi-Fi) System for eight District locations to Xtivity Solutions, LLC, in the Contract Price of \$125,342.00.

STRATEGIC DIRECTION SUPPORTED: Organizational Sustainability

FINANCIAL DATA: This item is budgeted for in FY2023, in accounts 91124100-805100 (\$100,000.00) and 15814100-805100 (\$26,690.00).

BACKGROUND: As a part of our Information Technology network infrastructure upgrades, we will be replacing a centrally managed and secured wireless networks at the General Offices (Indoor) and Greenbelt Cultural Center (Indoor). In addition, we will be adding services at the Ryerson Welcome Center (Indoor), Operations & Public Safety building (Indoor), Countryside Golf Club (Indoor), Thunderhawk Golf Club (Indoor), and Independence Grove (Indoor and Outdoor) to provide employees and guests with wireless access to network resources and the internet.

Xtivity Solutions was chosen based on the close match of their Request for Proposal (RFP) response to our request. Xtivity offers a superior hardware platform and their architecture provides a unified voice, data and radio frequency (RF) management platform. Additionally, this solution will provide new network infrastructure at Independence Grove outdoor facilities (Beer Garden, Marina, and Millennia Plaza Concert Area) to replace failing 22-year-old copper telephone lines, which run underneath the lake.

Security of the wireless environment will be handled through 24 x 7 monitoring of the complete wireless environment. This includes compliance monitoring, rogue detection and termination, and advanced troubleshooting.



Xtivity Solutions will provide and install an EnGenius managed cloud-controlled Wi-fi network using Wi-Fi 6 AX Access Points at all 7 locations covered in the mandatory walk through. The Lake County Forest Preserve (LCFP) network will have the ability to manage remote sites. The Wireless network will have the ability to configure separate internal and external network access for workers and guests. The 4x4 EnGenuisAX indoor and outdoor AP's can support up to 500+ clients per AP. The network will be configured and managed with the EnGenius Basic Cloud Controller but can be configured with an On-Premise controllers with a slightly higher cost. Xtivity recommends using the Cloud Basic controller for the management of this wireless network.
