**RECOMMENDATION:** Recommend approval of a Resolution awarding a Contract for Tree Removals along the Des Plaines River Corridor to Clean Cut Tree Service, Inc. in the Contract Price of \$178,498.24.

STRATEGIC DIRECTIONS SUPPORTED: Public Access and Connections; Conservation

FINANCIAL DATA: This project was approved as part of the adopted FY '22 and '23 Budget in the amount of \$300,000.00 (\$150,000.00 each FY). The actual cost of \$178,498.24 will be charged to the Land Development fund, account (20564400-704600).

BACKGROUND: The Tree Removal project to be performed within multiple preserves along the Des Plaines River Corridor includes a mixture of flatwoods, prairie, and savanna communities. Dead or dying trees near public use areas of the District can present a hazard to the public. Therefore, staff monitors public areas, such as trails and parking lots, for dead or dying trees and then addresses identified hazard trees. There are more identified hazard trees than staff is able to address, so funding for contractual tree removal has been allocated in the District's operating budget.

Work shall include mechanical cutting and hand cutting (chain saws, hand saws), brush disposal via chip and haul. Most of the work site is located in upland areas, but will also include a few areas near or within wetlands. The goal of this project is to mitigate hazardous trees.

The project was advertised on September 14, 2022 and three bids were received. A summary of the bids received is listed below:

Staff recommends that Clean Cut Tree Service, Inc. be awarded the contract as the lowest responsible bidder. Work is anticipated to begin December 15, 2022 and be completed by December 31, 2023.

WHEREAS, the Lake County Forest Preserve District (the "District") has advertised in <u>The Lake County News Sun</u> for sealed bids for a Contract for Tree Removals along the Des Plaines River Corridor (the "Work"); and

WHEREAS, all sealed bids were received and opened by the District at its General Offices, 1899 West Winchester Road, Libertyville, Illinois on October 4, 2022 at 11:00 a.m. local time; and

<u>Section 4:</u> <u>Payments.</u> The Treasurer shall make payments under the Contract only pursuant to and in accordance with the Contract terms.
