**RECOMMENDATION:** Recommend approval of a Resolution awarding a Contract for the purchase of prefabricated shade shelter materials for the off-leash dog area at the Duck Farm Forest Preserve to Cunningham Associates, Inc., in the Contract Price of \$46,292.00.

**STRATEGIC DIRECTION SUPPORTED:** Public Access and Connections.

<u>FINANCIAL DATA</u>: Improvements to the Duck Farm off-leash dog exercise area were approved as part of the adopted FY2022 Capital Improvement Plan in the amount of \$220,000.00 (11104100-803200-60025).

**BACKGROUND:** A Transition Plan (Plan) was prepared in late 2018 that identified required modifications to the District's facilities, property, programs, communications, policies and procedures to enhance compliance with the Americans with Disabilities Act (ADA) and the Illinois Accessibility Code. The Plan has served as a guide for improving District-wide accessibility for people of all ages and abilities. One of the priorities identified in this Plan was to address the offleash dog areas. As part of the implementation of phase I of the Plan, the District designed and constructed the Waukegan Savanna off-leash dog area to meet ADA requirements and opened the facility in the fall of 2019.

Continuing the focus on dog exercise areas, an improvement plan and engineering were completed for the Duck Farm off-leash dog area in early 2022. The project includes accessible parking stalls, accessible routes to a new evaporator restroom, drinking fountains and shade shelters, secure entry fencing system, improved boundary fencing for designated large and small dog use areas, water service connection to new code compliant drinking fountains, code compliant seating, asphalt repairs, striped crosswalk, drainage, fine grading and seeding.

The project was originally advertised for bids on June 7, 2022 for a contractor to complete the majority of the work. The District received only one bid and staff elected not to present that bid to Committee because it was significantly over budget. Staff recommends constructing the entire project using labor provided by District construction crews and materials furnished through the project budget.

The shade shelters for the Duck Farm off-leash dog area are pre-engineered, factory-fabricated steel structures. They are the same ones installed at the Waukegan Savanna Forest Preserve. One is

18' x 18' square, while the other is 24' x 24' square. The materials to be purchased would include templates, HDG anchor bolts, washers and nuts.

The shade shelter material purchase was originally advertised on September 15, 2022 and four bids were received. These bids were all rejected for a variety of reasons including not using the District's bid form, submitting the incorrect product or being significantly over budget. Staff decided to wait for a more favorable bidding climate in hopes of securing a more competitive price.

The shade shelter material purchase was advertised a second time on December 22, 2022 and three bids were received. A summary of the bids received is listed below:

Staff recommends that Cunningham Associates, Inc, be awarded the contract as the lowest responsible bidder. Materials are anticipated to be furnished by June 30, 2023.
