RECOMMENDATION: Recommend approval of a Resolution awarding a Contract for Reforestation Fencing Removals at Rollins Savanna to Mazarini, Inc., in the contract price of \$44,750.96.

STRATEGIC DIRECTION SUPPORTED: Conservation

FINANCIAL DATA: Reforestation was approved as part of the adopted FY 2023 CIP Budget in the amount of \$100,000.00 (11104100-803200-60008), of which \$44,750.96 will support the timely removal of protective fencing materials. Funds remaining are committed to planting and watering trees and shrubs at various preserves.

BACKGROUND: The District regularly plants native trees and shrubs to restore and enhance degraded areas. When trees and shrubs are installed, light-duty fencing materials are installed around these plantings to protect the newly planted material from damage and/or herbivory. After time, plants become well-established and the protective fencing is no longer required.

The work of this project includes all labor, equipment and materials necessary to remove the tree protection fencing from the planted material and off-site disposal. The goal of this project is to remove fencing material from trees planted in several areas at Rollins Savanna Forest Preserve in 2005 and 2006.

The project was advertised on January 5, 2023 and one bid was received:

Staff recommends that Mazarini, Inc. be awarded the contract as the lowest responsible bidder. Work is anticipated to begin in summer, when site conditions are dry, and be completed by December 15, 2023.
