**RECOMMENDATION:** Recommend Approval of a Resolution to amend the current Cooperative Service Agreement with the United States Department of Agriculture (USDA) to provide office space and other amenities for the USDA at the Operations and Public Safety Facility.

**STRATEGIC DIRECTIONS SUPPORTED:** Leadership; Conservation; Organizational Sustainability

**FINANCIAL DATA:** There is no financial impact at this time.

**BACKGROUND:** On May 1, 2023, the Operations Committee gave policy direction to District staff to negotiate the amendment requested by USDA. Staff has completed negotiations and recommends approval of the amendment.

The Lake County Forest Preserve District ("District") has been managing populations of whitetail deer and other wildlife for 35 years to reduce ecological and other property damage and to ensure public safety. These activities have been conducted with the cooperation of the USDA with Board approval since 2002. Under a Cooperative Service Agreement already in place, in exchange for financial consideration (approximately \$25,000 per year) USDA acts as the District's contractor assisting District in performing the District's wildlife management programs, including (i) the urban deer management program, (ii) sensitive species recovery efforts, including, for the Blanding's turtle program, helping to reduce nest predation and monitoring of individual turtles, and (iii) mitigating the impacts of beaver damage, including flooding of trails, roadways, and neighboring properties.

The USDA would like to increase the capacity of the Cooperative Service Agreement by embedding an Assistant District Supervisor (ADS) and other personnel within the Operations and Public Safety facility (Operations Facility) in Lindenhurst, IL. Specifically, USDA has requested (i) the use of office space at the Operations Facility to perform administrative duties, (ii) parking for a wildlife service truck, a trailer and UTV, (iii) storage for equipment used while aiding under the Cooperative Service Agreement, (iv) space for a gun safe to provide secure weapons storage, which can be provided behind a locked door in the Operations Facility.

The ADS is responsible for assisting the District with planning, directing, coordinating, and administering its Wildlife Program to efficiently and effectively reduce adverse wildlife-related impacts to agriculture, property, and natural resources, and to reduce wildlife impacts on human

health and safety. The ADS assists cooperative agencies to effectively and efficiently implement established wildlife damage management techniques as necessary to meet program needs and to address specific environmental and/or economic considerations.

Providing office space in support of the collaborative efforts with the USDA is likely to result in benefits to the District, including reduced travel time, and the associated expenses, when the ADS is conducting District-related activities. Specifically, the reduction of ADS expenditures for transportation from the USDA base of operations at O'Hare Airport will allow a greater proportion of the Great Lakes Research Initiative and other funding to be directed to Blanding's turtle recovery. Other benefits are likely to include greater capacity for the evaluation and monitoring of wildlife damage management and expediting USDA assistance when emergency assistance is required.
