RECOMMENDATION: Recommend approval of a Resolution awarding Contracts for Golf Course Plant Protectant Products to Advanced Turf Solutions, BTSI, Clesens Inc., Heritage Landscape Supply Group, Inc., Pendelton Turf Supply, Inc., Simplot AB Retail, Inc., SiteOne Landscape Supply, Masterblend International LLC, and Van Diest Supply in a total amount not to exceed \$379,400.00.

STRATEGIC DIRECTIONS SUPPORTED: Organizational Sustainability; Conservation

FINANCIAL DATA: The District's approved FY2024 budget provides for payment for these products with \$379,400.00 in the Revenue Facilities Grounds Commodities accounts. Specific account codes are shown on Appendix A to this memorandum.

BACKGROUND: These products are purchased annually and used on an as-needed basis to maintain the golf courses. Each yellow highlighted bid listed on the Exhibit attached to the resolution is the lowest bid for the corresponding type of Product. The staff recommends that the Board find these to be the lowest responsible bids. The bids highlighted in blue on the Exhibit either (i) do not conform to the bidding specifications because they include unacceptable alternate products or container sizes, or (ii) reflect prices that the bidders will not hold for the term of the contract. The staff recommends the rejection of bids that are highlighted in blue.

Amendment: This agenda item has been modified from the version presented to the Operations Committee on Tuesday March 4, 2024. Heritage Landscape Supply Group, Inc., submitted the low bid for a product call Precip, but emailed the District about an hour after the Operations Committee ended, stating that it quoted its price for Precip in error and will not be able to provide Precip to the District. District staff considers this a request by Heritage to withdraw its low bid for Precip only and recommends that the Board grant the request, and award a contract for Precip to the bidder who submitted the next lowest bid. The product is on page two of Exhibit A.

**A RESOLUTION AWARDING CONTRACTS FOR THE PURCHASE OF
GOLF COURSE PLANT PROTECTANT PRODUCTS**

WHEREAS, the Lake County Forest Preserve District (the “District”) has advertised in The Lake County News Sun for sealed bids to purchase plant protectant products, which are listed under the column titled “PRODUCT DESCRIPTION” on the attached exhibit (the “Products”); and

WHEREAS, all sealed bids were received and opened by the District at its General Offices, 1899 West Winchester Road, Libertyville, Illinois on January 30, 2024 at 11:00 a.m. and such bids are summarized on the exhibit attached hereto (the “Exhibit”); and

WHEREAS, the Board of Commissioners hereby finds that the blue highlighted bids in the Exhibit (i) are for incorrect or unacceptable alternate products, container sizes, or units of measure that do not conform to bidding specifications for the Products, or (ii) reflect prices that the bidders will not hold during the terms of the proposed Contracts (defined below) (collectively, the “Non-Conforming Bids”); and

WHEREAS, Heritage Landscape Supply Group, Inc. (“Heritage”) has stated that its bid for the Product Precip (highlighted in Blue on the Exhibit) (the “Heritage Precip Bid”) was submitted in error and has requested that it be allowed to withdraw the Heritage Precip Bid, and staff recommends that the Board grant this request; and

WHEREAS, the District’s staff, the Purchasing Manager, the Director of Golf Operations, and the Operations Committee and the Finance Committee have reviewed the bids and recommend that the Board of Commissioners: (i) find that each yellow highlighted bid listed on the Exhibit (collectively, the “Low Bids”) is a lowest responsible bid for the corresponding type of Product listed in the “PRODUCT DESCRIPTION” column of the Exhibit and (ii) award contracts for the Products to each of Advanced Turf Solutions, BTSI, Clesens Inc., Heritage Landscape Supply Group, Inc., Pendelton Turf Supply, Inc., Simplot AB Retail, Inc., SiteOne Landscape Supply, Masterblend International LLC, and Van Diest Supply (collectively the “Low Bidders”) for the Products for which each Low Bidder submitted the Low Bid, pursuant to which the District may purchase such amounts of the Products that it determines are necessary or desirable for District use (the “Contracts”); and

WHEREAS, the Board of Commissioners hereby finds that each Low Bid is a lowest responsible bid for the corresponding type of Product listed in the “PRODUCT DESCRIPTION” column of the Exhibit;

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Lake County Forest Preserve District, Lake County, Illinois THAT:

Section 1. Recitals. The recitals set forth above are incorporated as a part of this Resolution by this reference.

Section 2. Rejection of Non-Conforming Bids. The Non-Conforming Bids are hereby rejected.

Section 3. Approval to Withdraw Bid. Heritage is hereby granted permission to withdraw the Heritage Precip Bid.

Section 4. Acceptance of Bids and Award of Contracts. The Low Bids in the amounts listed on the Exhibit (the "Contract Prices") are hereby accepted, and Contracts for the Products are hereby awarded to the Low Bidders. The Executive Director of the District is hereby authorized to execute the Contracts for the Products in the amount of the Contract Prices.

Section 5. Payments. The Treasurer shall make payments under the Contracts only pursuant to and in accordance with the Contracts' terms.

Section 6. Effective Date. This Resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.
