RECOMMENDATION: Recommend approval of a Resolution awarding Contracts for the Purchase of Natural Resources Herbicides to Nutrien Ag Solutions, Inc. and to Heritage Landscape Supply Group, Inc., in a total amount not to exceed \$60,000.00.

STRATEGIC DIRECTIONS SUPPORTED: Organizational Sustainability; Conservation

<u>FINANCIAL DATA:</u> The District's approved FY2024 budget provides for payment for these products in the amount of \$60,000.00 from the Natural Resources Grounds Maintenance Supplies account (27643800-641100).

BACKGROUND: Herbicide products are purchased annually and used at forest preserves throughout the District on an "as-needed" basis. The Request for Bids was advertised on February 14, 2024, and three bids were received. Staff recommends that Nutrien Ag Solutions, Inc. and Heritage Landscape Supply Group, Inc. be awarded contracts as the lowest responsible bidders for the herbicide products.

A RESOLUTION AWARDING CONTRACTS FOR THE PURCHASE OF HERBICIDES

WHEREAS, the Lake County Forest Preserve District (the "District") has advertised in The Lake County News Sun for sealed bids to purchase herbicides, which are listed under the column titled "PRODUCT DESCRIPTION" on the attached exhibit (the "Products"); and

WHEREAS, all sealed bids were received and opened by the District at its General Offices, 1899 West Winchester Road, Libertyville, Illinois on February 28, 2024 at 11:00 a.m., and such bids are summarized on the exhibit attached hereto (the "Exhibit"); and

WHEREAS, the District's staff, the Purchasing Manager, the Director of Natural Resources, and the Operations Committee have reviewed the bids and recommend that the Board of Commissioners: (i) find that each highlighted bid listed on the Exhibit (collectively, the "Low Bids") is a lowest responsible bid for the corresponding type of Product listed in the "PRODUCT DESCRIPTION" column of the Exhibit and (ii) award contracts for the Products to each of Heritage Landscape Supply Group, Inc. and Nutrien Ag Solutions, Inc., (collectively the "Low Bidders") for the Products for which each Low Bidder submitted a Low Bid, pursuant to which the District may purchase such amounts of the Products that it determines are necessary or desirable for District use (the "Contracts"); and

WHEREAS, the Board of Commissioners hereby finds that each Low Bid is a lowest responsible bid for the corresponding type of Product listed in the "PRODUCT DESCRIPTION" column of the Exhibit;

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Lake County Forest Preserve District, Lake County, Illinois THAT:

<u>Section 1.</u> Recitals. The recitals set forth above are incorporated as a part of this Resolution by this reference.

Section 2. Acceptance of Low Bids and Award of Contracts. The Low Bids in the amounts listed on the Exhibit (the "Contract Prices") are hereby accepted and Contracts for the Products are hereby awarded to the Low Bidders. The Executive Director of the District is hereby authorized to execute the Contracts for the Products in the amounts of the Contract Prices.

<u>Section 3.</u> <u>Payments</u>. The Treasurer shall make payments under the Contracts only pursuant to and in accordance with the Contracts' terms.
