RECOMMENDATION: Recommend approval of a Resolution approving a Consent to Relocation of Cemetery Access Easement Agreement with the Department of Veterans Affairs (the "VA"), for access to the Fort Sheridan National Cemetery (the "Cemetery") at Fort Sheridan Forest Preserve.

STRATEGIC DIRECTIONS SUPPORTED: Public Access and Connections, Organizational Sustainability

<u>FINANCIAL DATA</u>: The District's License and Easement Ordinance generally requires an easement grantee to pay a monetary fee to the District for the fair market value of an easement. However, the District is compelled to provide and maintain the easement under the 1998 deed that conveyed Fort Sheridan from the Army to the District. As such, the District will not ask the VA to pay a fee for the relocated easement.

BACKGROUND: When the District accepted title to the initial parcel of the Fort Sheridan property (the "Property") on March 3, 1998, the Property was encumbered by a non-exclusive easement and right-of-way on, over, and through the Property, for public access to the Cemetery (the "Cemetery Access Easement") using then-existing roads, which were identified on Exhibit E to the Quit Claim Deed (the "Cemetery Road"). The deed obligates the District to maintain the Cemetery Access Easement over the Cemetery Road in perpetuity to allow public access to the Cemetery, and provides that the Cemetery Easement shall bind the District and run with the land.

In 2006, as part of its restoration of the Property, the District removed the original Cemetery Road and constructed a new road named "Vattman Road." At that time, the District did not obtain prior approval from the VA for the road relocation, which now needs to be formally documented. The District and the VA desire to enter into an agreement to memorialize the VA's consent to the removal of the original Cemetery Road, construction of Vattman Road, and the relocation of the Cemetery Access Easement to Vattman Road.

A RESOLUTION APPROVING A CONSENT TO RELOCATION OF CEMETERY ACCESS EASEMENT AGREEMENT WITH THE DEPARTMENT OF VETERANS AFFAIRS FOR ACCESS TO THE FORT SHERIDAN NATIONAL CEMETERY AT FORT SHERIDAN FOREST PRESERVE

WHEREAS, the Lake County Forest Preserve District (the "District") owns certain parcels of land known as Fort Sheridan Forest Preserve (the "Property") located in Moraine Township; and

WHEREAS, the United States of America, acting by and through the United States Army, previously conveyed the Property to the District; and

WHEREAS, portions of Property were conveyed subject to a perpetual, non-exclusive easement and right-of-way on, over, and through the Property for public access to Fort Sheridan National Cemetery (the "Cemetery Access Easement") via then-existing roads, as shown on Exhibit A (the "Original Roads"); and

WHEREAS, in 2006, the District removed the Original Roads and constructed a new road named "Vattman Road," as shown on Exhibit B, which provides access to Fort Sheridan National Cemetery; and

WHEREAS, the District and the United States of America, acting by and through the Department of Veterans Affairs (the "VA"), desire to memorialize the VA's consent to the removal of the Original Roads, the construction of Vattman Road, and the relocation of the Cemetery Access Easement to Vattman Road; and

WHEREAS, Section 6 of the Downstate Forest Preserve District Act, 70 ILCS 805/6, authorizes the District to grant easements and rights-of-way on District property for the construction, operation, and maintenance of public services; and

WHEREAS, District staff has negotiated a Consent to Relocation of Cemetery Access Easement Agreement with the VA in the form attached hereto, pursuant to which the District will grant a perpetual, non-exclusive easement to the VA for public access to the Fort Sheridan National Cemetery via Vattman Road, and the VA will release the existing Cemetery Access Easement over the Original Roads (the "Easement Agreement");

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Lake County Forest Preserve District, Lake County, Illinois **THAT**:

Section 1: Recitals. The recitals set forth above are incorporated as a part of this Resolution by this reference.

<u>Section 2:</u> <u>Approval of Easement Agreement.</u> The Easement Agreement with the VA is approved in substantially the form attached hereto. The President and Secretary of the District are hereby authorized and directed to execute and attest to, on behalf of the District, the Easement


Agreement. In the event that any provision of the Easement Agreement conflicts with the License and Easement Ordinance, the conflicting provision of the License and Easement Ordinance is hereby waived.

<u>Section 3:</u> <u>Effective Date.</u> This Resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.

Original Right-of-Way Easement





CONSENT TO RELOCATION OF CEMETERY ACCESS EASEMENT

RECITALS

- A. On February 20, 1998, the **Lake County Forest Preserve District**, a body corporate and politic and unit of local government organized and existing under the Downstate Forest Preserve District Act, 70 ILCS 805/0.001 *et seq.*, located at 1899 West Winchester Road, Libertyville, IL 60048 ("<u>District</u>"),and the United States of America, acting by and through the Secretary of the Army (the "<u>Army</u>"), entered into that certain "Memorandum of Agreement between the United States of America, acting by and through the Secretary of the Army, United States Department of the Army and Lake County Forest Preserve District for the Conveyance of a Portion of Fort Sheridan Located in Lake County, Illinois" (the "<u>1998 MOA</u>").
- B. The 1998 MOA (under AGREEMENT TO CONVEY) required the Army to convey to the District certain real property defined in the MOA as the "Property", which is legally described on Exhibit A attached hereto (the "Property"). On February 27, 1998, the Army executed a Quit Claim Deed conveying a portion of the Property (the "Phase I Property") to the District (the "Quit Claim Deed"). On March 3, 1998, the District accepted the Quit Claim Deed and the conveyance of the Phase I Property. On March 3, 1998, the Quit Claim Deed was recorded as Document No. 4095134, by the Recording Division of the Lake County Clerk's Office, Lake County, Illinois.
- C. Pursuant to the 1998 MOA (under Section 2.d of DELIVERY OF POSSESSION; TITLE; NOTICE; ENCUMBRANCES) the Quit Claim Deed (i) reserved to the Army a non-exclusive easement and right-of-way on, over, and through the Property, for public access to the Cemetery (the "Cemetery Access Easement") using then-existing District roads, which were identified on Exhibit F to the 1998 MOA and Exhibit E to the Quit Claim Deed (the "Cemetery Road") and (ii) obligates the District to maintain the Cemetery Access Easement over the Cemetery Road in perpetuity to allow public access to the Cemetery in accordance with standards

stated therein, and (iii) provides that the Cemetery Easement shall bind the District and run with the land.

- D. On December 13, 2019, the Army transferred to the VA operating control and administrative jurisdiction over the Cemetery, pursuant to the letter dated December 13, 2019.
- E. On October 25, 2019, the Army, the VA, and the District entered into that certain "First Amendment to Memorandum of Agreement between the United States of America, Acting by and through the Secretary of the Army, United States Department of the Army and Lake County Forest Preserve District for the Conveyance of a Portion of Fort Sheridan Located in Lake County, Illinois dated February 20, 1998" (the "First Amendment to 1998 MOA"; the 1998 MOA, as amended by the First Amendment to 1998 MOA, is the "Amended 1998 MOA"). The First Amendment to 1998 MOA (i) acknowledged that jurisdiction of the Cemetery would transfer from the Army to the VA, (ii) amended certain provisions of the 1998 MOA, and (ii) provides that the VA will have all future responsibilities and access rights to act for the United States regarding Cemetery matters, including the right to amend the Amended 1998 MOA with concurrence of the District.
- F. After the Quit Claim Deed was recorded, the District removed the original Cemetery Road and constructed a new road named "Vattman Road", and the VA has consented to such removal and construction.
- G. The District and the VA desire to memorialize the VA's consent to the removal of the original Cemetery Road, the construction of Vattman Road and the relocation of the Cemetery Access Easement to Vattman Road.

NOW, THEREFORE, for good and valuable considerations, the receipt and sufficiency of which are hereby acknowledged, VA states as follows:

- 1. <u>Termination and Release of Easement</u>. The VA hereby consents to the removal of the original Cemetery Road, the construction of Vattman Road and the relocation of the Cemetery Access Easement to Vattman Road. For all purposes under the 1998 MOA and the Quit Claim Deed, the "Cemetery Road" shall mean Vattman Road, and the "Cemetery Access Easement" shall mean the area depicted on the Plat of Easement dated November 11, 2023 attached hereto as <u>Exhibit B</u>, and recorded of even date herewith by the Recording Division of the Lake County Clerk's Office, Lake County, Illinois.
- 2. <u>Miscellaneous</u>. This Consent shall be construed in accordance with Federal law. If Federal law is silent, then the law of the State of Illinois applies. The paragraph headings of this Consent and the captions of the exhibits attached hereto are for convenience only and are not intended, and shall not be construed to alter, limit or enlarge in any way the scope or meaning of the language contained in this Termination and exhibits attached hereto. This Consent shall extend to, be binding upon and inure to the benefit of the VA and the District and their respective successors, assigns, heirs and legal representatives.
