RECOMMENDATION: Recommend approval of a Resolution awarding a two-year Contract for printing and distribution of eight issues of *Horizons* magazine to Dreamworks Graphic Communications, LLC, in the amount of \$198,216.00.

STRATEGIC DIRECTIONS SUPPORTED: Public Access and Connections, Organizational Sustainability, Communication, Education & Outreach.

FINANCIAL DATA: Funding is included in the Community Engagement and Partnerships budget in account 11354000-702100. Eight issues are included (fall 2024, winter 2024, spring 2025, summer 2025, fall 2025, winter 2025, spring 2026, summer 2026) in the total amount of \$198,216.00.

BACKGROUND: As the District's lead print communications tool, *Horizons* focuses on educating Lake County residents about our commitment to open space preservation, trails, wildlife habitat, education, strategic plan goals, fundraising efforts, and responsible use of referenda funds. Engaging editorial, high-impact photography and graphic design create a memorable presence and leaves readers with a positive perception of their Lake County Forest Preserves.

Horizons is regularly used as an introduction and leave-behind piece for constituents and potential donors. It also serves as a catalyst and engagement piece for Preservation Foundation giving initiatives. Each issue includes news about the Foundation and a donation envelope. In 2023, \$21,122 in Foundation revenue was directly attributed to the envelope.

Mailed to roughly 33,500 subscribers each quarter, *Horizons* reaches the single largest audience of District supporters. By request, another 7,500 copies are distributed each quarter to medical offices, retail outlets, businesses, real estate agents, municipalities, park districts, libraries, hotels, restaurants, Visit Lake County, various chambers of commerce, and District facilities.

Horizons content drives readers to the District's website, e-newsletters, and social media outlets such as Facebook, Instagram, LinkedIn, X and Flickr where they can find additional resources and become further engaged with the District's mission. It also helps promote the sale of permits and gift cards and participation in education programs and events, summer camps, facility rentals, the Beer Garden at Independence Grove, summer concerts, marina rentals, Fox River boat slips, and Dunn Museum exhibitions and events. Feature articles cover a variety of topics on nature and wildlife, preserve and facility amenities, and the history of Lake County.

Bids were solicited for printing and distributing eight issues of *Horizons* (41,000 copies per issue; 328,000 total copies) beginning with the fall 2024 issue and ending after the printing of the summer 2026 issue. Sealed bids were received and opened by the District at its General Offices, 1899 West Winchester Road, Libertyville, Illinois, on April 3, 2024, at 11:00 a.m. Bids were received in the following amounts from the following bidders:

Staff recommends that Dreamworks Graphic Communications, LLC, be determined to be the lowest responsible bidder. Based on its review, staff has concluded that this bidder meets all of the project specifications and has provided evidence of its ability to successfully fulfill this contract. This bidder is the current printing contractor for *Horizons*.

The Dreamworks Graphic Communications eight-issue contract bid is itemized as follows:
