RECOMMENDATION: Recommend approval of a Resolution awarding a Contract for Pavement Patching and Crack Sealing at Multiple Forest Preserves to Chicagoland Paving Contractors, Inc., in the Contract Price of \$135,000.00.

STRATEGIC DIRECTIONS SUPPORTED: Public Access and Connections; Organizational Sustainability.

FINANCIAL DATA: This work was included in the adopted FY2024 Capital Improvement Plan (CIP) and FY2024 Budget as part of the following project: Repair Existing Roads/Parking (Project 60009). The total amount available in the budget is \$1,135,942.04. The actual amount of \$135,000.00 will be charged to 20104100-803200-60009.

BACKGROUND: The District uses asphalt pavement for roads, parking lots, and trails in various areas. Under the contract that would be approved by the attached resolution, the contractor would complete pavement "hot patching" (i.e., removal and replacement of a deteriorated portion of pavement) and crack sealing, which helps prevent water from entering cracks, thereby preventing or delaying asphalt failure. Staff assessed paved areas District-wide and determined that pavement patching and crack-sealing is recommended at several preserves including: Fort Sheridan, Fourth Lake, Grant Woods, Lakewood, Marl Flat, Nippersink, Rollins Savanna and Sun Lake.

The project was advertised on June 10, 2024 and three (3) bids were received and opened on June 27, 2024. The bid amounts are:

WHEREAS, the Lake County Forest Preserve District (the "District") has advertised in <u>The Lake County News Sun</u> for sealed bids for certain site improvements at the District's General Offices (the "Work"); and

WHEREAS, all sealed bids received were opened by the District at its General Offices, 1899 West Winchester Road, Libertyville, Illinois, on June 27, 2024 at 11:00 a.m. local time; and

WHEREAS, bids were received in the following amounts from the following bidders:

WHEREAS, the District's staff, the Purchasing Manager, the Director of Planning, and the Planning Committee have reviewed the bids and recommend that the Board of Commissioners find Chicagoland Paving Contractors, Inc. to be the lowest responsible bidder for the Work and award a contract for the Work to Chicagoland Paving Contractors, Inc. (the "Contract"); and

WHEREAS, the Board of Commissioners hereby finds that Chicagoland Paving Contractors, Inc. is the lowest responsible bidder for the Work;

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Lake County Forest Preserve District, Lake County, Illinois, **THAT**:

Section 2: Award of Contract. The bid submitted by Chicagoland Paving Contractors, Inc. in the amount of \$135,000.00 (the "Contract Price") is hereby accepted, and a Contract for the Work is hereby awarded to Chicagoland Paving Contractors, Inc. in the amount of the Contract Price.

Section 3: Execution of Contract. The Executive Director of the District is hereby authorized and directed to execute the Contract for the Work in the amount of the Contract Price.

<u>Section 4:</u> <u>Payments.</u> The Treasurer shall make payments under the Contract only pursuant to and in accordance with the Contract terms.
