**RECOMMENDATION:** Recommend approval of a Resolution awarding a Contract for the Construction of Nature Play Area at Lakewood Forest Preserve to AGAE Contractors, Inc., Elk Grove Village, Illinois, in the Contract Price of \$1,230,536.19.

#### **STRATEGIC DIRECTIONS SUPPORTED:** Public Access and Connections

FINANCIAL DATA: Implementing the Lakewood Master Plan was approved as part of the adopted FY2023 Capital Improvement Plan in the amount of \$6,061,690.19. Additional funding in the amount of \$1,000,000.00 was provided through two IDNR OSLAD grants and an additional \$20,000.00 was provided through an Illinois Clean Energy Community Foundation grant. Therefore, the overall budget for improvements was \$7,081,690.19, of which \$1,597,357.48 remains. The actual total cost of the contract that would be approved by the attached resolution (Construction of Nature Play Area) is \$1,230,536.19 and will be charged to the following account: 11104100-803200-61020.

**BACKGROUND:** In January 2020, the Board of Commissioners approved a comprehensive Master Plan for Lakewood Forest Preserve. Four main goals guided the preparation of the Master Plan including: (i) provide an improved public access and recreation experience that is ADAcompliant, properly-sized, accommodates future needs, and reduces short-term and long-term operating costs, (ii) provide a new and more efficient design which consolidates uses within a smaller footprint, supports the District's educational programs and community events, and satisfies current and future public access needs, (iii) replace and/or renovate critical operational infrastructure and (iv) dedicate new areas for restoration consistent with the District's natural resource goals. The Master Plan called for several new public access improvements including, but not limited to, a nature-based children's play area (the "Nature Play Area").

The second OSLAD grant received by the District is a \$600,000 grant for the Nature Play Area. Under the grant terms, the District must expend at least \$1,200,000 for the Nature Play Area to be reimbursed the full \$600,000 amount of the grant. The District has expended approximately \$208,000 on the Nature Play Area to date. As such, the expenditure of over \$1.2 million on this contract will entitle the District to the maximum amount of the \$600,000 grant.

The contract for construction of the Nature Play Area was advertised on June 11, 2024. Four (4) bids were received and opened on July 8, 2024. The invitation for bids called for a base bid and five bid alternates.

In accordance with the Purchasing Policy and the invitation for bids, staff negotiated with the low bidder to adjust pay item quantities to reduce the total of the low bid. Staff recommends that AGAE Contractors, Inc. be awarded the contract as the lowest responsible bidder for the construction of the Nature Play Area. Work is anticipated to begin August 26, 2024 and be completed by November 1, 2025.
