RECOMMENDATION: Recommend approval of a Resolution awarding a Contract for Woody Invasive Plant Clearing at MacArthur Woods Forest Preserve to Tallgrass Restoration, LLC in the Contract Price of \$57,915.00.

STRATEGIC DIRECTION SUPPORTED: Conservation

FINANCIAL DATA: This project was approved as part of the adopted FY2024 Budget in the amount of \$100,000. This portion of the project was estimated at \$40,000.00. The actual cost of \$57,915.00 will be charged to the Habitat Restoration Fund (11104100-803200-60004).

BACKGROUND: Invasive plants are a significant challenge to habitat conservation. Management of invasive plants is necessary to improve and conserve habitat quality and species diversity on District properties throughout Lake County. The District conducts removal of invasive woody species as part of a Land Management Program to restore and enhance woodlands, savannas, prairies and wetlands; to increase the health, diversity and sustainability of flora and wildlife populations; and to restore or enhance ecosystem services ("Clearing Projects").

The District advertised for bids for the Woody Invasive Plant Clearing at MacArthur Woods Forest Preserve. Work includes all labor equipment and materials to selectively remove invasive woody trees and shrubs and thin select native species and includes disposal services and follow-up selective herbicide applications. A portion of the work originally included mowing, however due to budgetary constraints, this portion of the project has been removed from the project work.

The project was advertised on July 31, 2024 and four bids were received. A summary of the bids received is listed below:

Staff recommends that Tallgrass Restoration, LLC be awarded the contract as the lowest responsible bidder. Work is anticipated to begin October 22, 2024 and be completed by August 1, 2025.

WHEREAS, the Lake County Forest Preserve District (the "District") has advertised in <u>The Lake County News Sun</u> for sealed bids for the Woody Invasive Plant Clearing – Winter 2024 Project at MacArthur Woods Forest Preserve (the "Work"); and

WHEREAS, all sealed bids were received and opened by the District at its General Offices, 1899 West Winchester Road, Libertyville, Illinois on August 14, 2024 at 2:00 p.m. local time and such bids are identified on Exhibit A; and

WHEREAS, the District's staff, the Purchasing Manager, the Director of Natural Resources, and the Operations Committee, have reviewed the bids and recommend that the Board of Commissioners (i) finds Tallgrass Restoration, LLC to be the lowest responsible bidder for the work and (ii) awards a contract for the Work (the "Contract") to Tallgrass Restoration, LLC; and

WHEREAS, the Board of Commissioners hereby finds that Tallgrass Restoration, LLC is the lowest responsible bidder for the Work;
