RECOMMENDATION: Recommend approval of a Resolution approving the disposal of surplus District vehicles, equipment, furnishings and other items.

STRATEGIC DIRECTION SUPPORTED: Organizational Sustainability

<u>FINANCIAL DATA:</u> Revenue from the sale of the surplus vehicles and equipment will be returned to the associated replacement or enterprise funds. All other proceeds will be returned to the General Fund.

BACKGROUND: From time to time, the District disposes of vehicles, equipment and other personal property items that have been replaced or are no longer needed. Staff recommends that the items described on Exhibit A attached to the Resolution be sent to public auction for sale. Staff further recommends that the items described on the attached Exhibit B be disposed of at no cost via transfer directly to a private party, eWorks Electronics Services, Inc. According to their website and communications with staff, (i) eWorks Electronics Services, Inc. creates employment opportunities for people with disabilities by providing recycling and refurbishment of office and consumer electronics, (ii) eWorks has two locations, with one being in Wheeling, Illinois and (iii) 48% (30) of its full-time staff identify as disabled. District staff intends for eWorks to either refurbish or recycle the transferred items.

A RESOLUTION APPROVING DISPOSAL OF SURPLUS VEHICLES, EQUIPMENT, FURNISHINGS AND OTHER ITEMS

WHEREAS, the Lake County Forest Preserve District (the "District") owns certain surplus vehicles, equipment, furnishings and other items described on the attached Exhibits A and B (collectively, the "Equipment"); and

WHEREAS, the Board of Commissioners hereby finds that the Equipment has outlived its useful life or is surplus and that it is no longer necessary to, useful to, or for the best interest of the District; and

WHEREAS, it is in the best interest of the District to dispose of the Equipment as provided herein;

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Lake County Forest Preserve District, Lake County, Illinois, **THAT**:

Section 1: Recitals. The recitals set forth above are incorporated as part of this Resolution by this reference.

Section 2: Auction of Equipment. The Executive Director, or his designee, is hereby authorized to cause the Equipment described on Exhibit A to be auctioned "as is," individually or in one or more lots, to the highest bidder and (ii) discard any Equipment for which no suitable bids are received.

Section 3: Transfer of Equipment. The Executive Director, or his designee, is hereby authorized to (i) cause the Equipment described on Exhibit B to be transferred for no cost "as-is" to eWorks Electronics Services Inc. and (ii) discard any such Equipment for which transfer is not accepted.

Section 4: Effective Date. This Resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.
