SUBJECT:

Development of a Green Infrastructure Strategy and Model for Lake County, Illinois

RECOMMENDATION: Recommend approval of an Ordinance Approving a Contract with The Conservation Fund for the development of a Green Infrastructure Strategy for Lake County, Illinois, in the Contract Price of \$90,000, Amending the FY 2014/15 Budget Ordinance, and Transferring appropriations in the FY 2014/15 Appropriations Ordinance.

BACKGROUND: The Lake County Forest Preserve District is leading an effort to develop a Geographical Information System data-driven, Green Infrastructure Strategy and Model for planning efforts of the District, and to guide regional, local and site green infrastructure planning by agencies, organizations, corporations and citizens of Lake County, Illinois. This project will enhance the Chicago Wilderness Green Infrastructure Vision product and build a more refined Green Infrastructure Strategy and Model for Lake County and adjacent lands. The project will develop a data product and GIS model support system to provide the District with planning information for the identification of three 10,000-acre ecological complexes, large-scale restoration projects, Lake Michigan ecological resources, improvement of water resources, and valuation of ecosystem services. The Green Infrastructure Strategy and Model will help county organizations and partners collaborate to (i) protect a network of green infrastructure in Lake County, including important natural resources, (ii) provide tools for site specific use of green infrastructure and (iii) provide guidance for the planning of gray infrastructure.

The District sent out a request for proposals and received three responses from the following firms:

Applied Ecological Services, Broadhead, Wisconsin

Cardno Corporation, Barrington, Illinois

The Conservation Fund, Washington D.C.

Staff interviewed Applied Ecological Services and The Conservation Fund and recommends that The Conservation Fund be awarded the contract as the firm submitting the proposal that is most advantageous to the District. Work is anticipated to begin June 2015 and be completed by January 2016.

Insufficient funding exists in the Land Development Levy Fund for this project, and it is recommended that the Board amend the FY 2014/15 budget and appropriations ordinances to transfer funds from the Farmland Management Fund to the Land Development Levy Fund to cover the expenses of the contract. District staff has been working with potential granting sources and, if funding does become available, the Farmland Management Fund will be refunded. If grant funds are not secured, the \$90,000 decrease in the Farmland Management Fund would require the postponement of soil and drain tile surveys currently planned for FY 2015/16.

REASON FOR RECOMMENDATION: Committee recommendation and Board approval are required in accordance with District policy.

AN ORDINANCE APPROVING A CONTRACT WITH THE CONSERVATION FUND FOR THE DEVELOPMENT OF A GREEN INFRASTRUCTURE STRATEGY AND MODEL, AMENDING THE BUDGET ORDINANCE, AND TRANSFERRING APPROPRIATIONS

WHEREAS, the Lake County Forest Preserve District (the "District") desires to retain a firm to develop a Green Infrastructure Strategy and Model for Lake County, Illinois (the "Services"); and

WHEREAS, the Director of Natural Resources and the Purchasing Manager have determined that the Services require personal confidence; and

WHEREAS, the Purchasing Manager has solicited proposals for the Services; and

WHEREAS, the District's staff, the Purchasing Manager, the Director of Natural Resources, and the Finance and Administrative Committee have reviewed the proposals and recommend that the Board of Commissioners (i) find that the proposal submitted by The Conservation Fund be determined to be the proposal that is most advantageous to the District, and (ii) award a contract for the Services to The Conservation Fund (the "Contract") in the amount of \$90,000.00 (the "Contract Price"); and

WHEREAS, the Board of Commissioners hereby finds that the proposal for the Services submitted by The Conservation Fund is the proposal that is most advantageous to the District; and

WHEREAS, on May 13, 2014, the District approved (i) Ordinance # 4807 approving the District's budget for the 2014/2015 fiscal year (the "2014/2015 Budget Ordinance") and (ii) Ordinance # 4808 approving the District's appropriations for the 2014/2015 fiscal year (the "2014/2015 Appropriations Ordinance"); and

WHEREAS, the District desires to pay for the Services using funds from its Land Development Levy Fund, but that fund currently has a balance insufficient to pay for the Services and, therefore, the District desires to transfer funds from its Farmland Management Fund to the Land Development Levy Fund; and

WHEREAS, the District is authorized to amend the 2014/2015 Budget Ordinance to transfer funds from its Farmland Management Fund to its Land Development Levy Fund; and

WHEREAS, pursuant to Section 13.5(b) of the Downstate Forest Preserve District Act, 70 ILCS 805/13.5(b), the District may transfer monies appropriated in the 2014/2015 Appropriations Ordinance that are not generated from real estate taxes or certain landfill charges from one appropriation in a fund to another appropriation within a different fund, if such transfer does not affect the total amount appropriated; and

WHEREAS, the monies in the Farmland Management Fund are not generated from real estate taxes or certain landfill charges, the transfer of \$90,000.00 for the Services will not affect the total amount appropriated, and therefore, the District may transfer such amount as set forth herein; and

WHEREAS, it is in the District's best interests to approve an amendment to the 2014/2015 Budget Ordinance and to transfer funds appropriated in the 2014/2015 Appropriations Ordinance, to effect a transfer of \$90,000.00 from the Farmland Management Fund to the Land Development Fund to pay for the Services;

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of the Lake County Forest Preserve District, Lake County, Illinois THAT:

Section 1. Recitals. The recitals set forth above are incorporated as a part of this Ordinance by this reference.

<u>Section 2.</u> Negotiation and Award of Contract. The Executive Director (or his designee) is hereby authorized and directed to negotiate the Contract with The Conservation Fund for the Services in the amount of the Contract Price, provided that the Contract shall require The Conservation Fund to provide Services to the District, all in accordance with the prices and other criteria identified on Exhibit A attached hereto (the "Contract Criteria").

After the Contract has been negotiated in accordance with the Contract Criteria, the Executive Director is authorized to award the Contract to The Conservation Fund and the Executive Director and Secretary of the District are authorized and directed to execute and attest to the Contract for the Services in the amount of the Contract Price.

Section 3. Amendment of Budget Ordinance. The 2014/2015 Budget Ordinance is hereby amended so that the following line items of Section 2, Part III (Estimated Expenditures) of the 2014/2015 Budget Ordinance will read as follows:

Land Development Levy Fund \$8,036,750.00 Farmland Management Fund \$397,630.00

Further, the District's Director of Finance (or his designee) is hereby authorized to amend the "Fiscal Year 2014/2015 Budget of the Lake County Forest Preserve District" attached as Exhibit A to the 2014/2015 Budget Ordinance so that it is consistent with this Ordinance.

<u>Section 4</u>. <u>Transfer of Appropriated Funds</u>. The District hereby transfers \$90,000.00 from funds appropriated to the Farmland Management Fund by the 2014/2015 Appropriations Ordinance to the Land Development Fund, so that the following line items of Section 2 of the 2014/2015 Appropriations Ordinance will hereafter read as follows:

Pursuant to Section 18-50 of the Illinois Property Tax Code (35 ILCS 200/18-50), the District Treasurer is hereby directed to execute a certification of the estimated revenues of the District, in a form approved by the District's General Counsel and the District Secretary is hereby directed to file a certified copy of this Ordinance with the County Clerk of Lake County, Illinois within 30 days after its passage and approval.

<u>Section 5. Payments.</u> The District Treasurer shall make payments under the Contract only pursuant to and in accordance with the Contract terms.

<u>Section 6</u>. <u>Effective Date.</u> This Ordinance shall be in full force and effect from and after its passage and approval in the manner provided by law.

EXHIBIT A

CONTRACT CRITERIA

A. Project Coordination

The selected firm should expect to hold at least 5 meetings (on-site, phone or web-based) with the Advisory Group and other partners to review results of the different tasks.

B. Data Gathering and Organization

The firm (in conjunction with the project partners) as an initial phase of this project will gather and organize data that will identify the existing green infrastructure network at as fine a level of detail as possible, based primarily on available data, aerial photos and planning efforts.

C. Connectivity Integration

The firm will identify optimum (or near-optimum) landscape and recreational linkages between green infrastructure core areas, and on that basis, identify areas of potential protection that could be pursued by the project partners.

D. Ranking and prioritization of network

The firm will rank individual geographic units of the Lake County green infrastructure network with the intent of showing the relative priority of conservation actions in the different parts of the Lake County and neighboring network.

E. Specific Project Development

The firm shall preform five case study analyses on the following selected areas of interest:

- An assessment of three 10,000 ecological complexes in and around Lake County
- An assessment of water resource capabilities and ground water recharge areas
- 3. An assessment of potential woodland, wetland and prairie opportunity areas
- 4. An assessment of Lake Michigan ravine and Lakeplain opportunities
- 5. An assessment of ecosystem valuation in Lake County

F. Deliverables

The firm shall prepare a final Green Infrastructure Strategy and Model for Lake, County Illinois report in PDF format suitable for posting on the web that describes results and documents all methods and data sources used in the project. The report should be written in language that is readable and non-technical as possible. The report should include graphics depicting methods and results were appropriate; at a minimum, the final report should include overview maps of all datasheets generated as part of the project.

The firm will provide raster or vector datasets characterizing the green infrastructure network, indicating minimum additional land preservation, remediation, restoration and protection to identify three 10,000-acre ecosystem complexes, their connections and ranking green infrastructure network components as outlined previously.

File Format shall be ERSU ArcMAP File Geodatabase, raster format must be compatible with ERSI ArcMAP.
